Margaret Baldino, Defendant in this case, state as follows:

Notice is given by the Defendant to the Court that Defendant acknowledges the error in signing the wrong page in the submission to the Court on November 22, 2016.

The wrongful signing was in the presence of the Court Clerk, to rectify,

- 1.) The Defendant now tenders a replacement "**Defendant's Answer to Plaintiff's Response to Defendant's Motion to Dismiss**" and is attached herein, signed.
- 2.) A replacement **Elder Waiver** is attached herein, unsigned, as it should have been when these documents were submitted.
- 3.) The error made by the Defendant was not intentional.


4.) As a separate matter touching on Procedure, having learned recently by the Defendant, it is in regard for Defendant's protection that mention be made of the September 20, 2016 visit to the Court in which the Defendant, her paid Attorney Mr. Heath, and Andrew Elder, Plaintiffs' Attorney, had come together before the Court for what was to be the Pre-Trial Conference.

For the record, it should be noted that while the Defendant had been led to believe that Mr. Heath was representing her in this present Case and Action, that in actuality what had followed a closed-door session between Mr. Heath and the Judge in this Matter, Mr. Heath emerged to inform the Defendant that he no longer could represent and fulfill his obligations to the Defendant, this done without written notice and seemingly without reason.

The Pre-Trial Conference was summarily concluded with the Judge's instruction that Trial was set for 10 weeks and 2 days later, December 1, 2016.

As pertaining to the aforementioned, it is requested of the Honorable Judge to allow for another Pre-Trial Conference where, without the aid of Mr. Heath, that the Plaintiff's Initial Claim might be assessed whether or not a valid Claim has been brought before the Court pertaining to the matter.
