

The Affiant, Deputy Mitchell, being first sworn, says there is probable cause to believe the defendant, John Reedy, committed an offense based on the summary of facts below:

On February 21, 2019 the Clark County Sheriff's Office received a 911 call from Alisha Castle. She explained that their was an unwanted guest by the name of John Reedy on her property at 1226 Sylvan Shores Drive in South Vienna Ohio.

Alisha has known John since grade school. They were boyfriend and girlfriend in 7th and 8th grade in 1998-1999. She stated that she had a normal relationship with John; however, John became very mean and controlling and they broke up. They remained casual friends in high school until she started receiving mean prank calls that were obscene in nature. Alisha recalled that John isolated himself from everyone at school. Around the same time John was diagnosed as a paranoid schizophrenic.

Alisha was advised from a third party at school that John blames her for his house being broken into. John then called Alisha and threatened to blow up their family home. After high school Alisha didn't hear from John for approximately 10 years although other people would advise her that John was obsessed with their childhood relationship. A lot of John's issues and problems somehow are directly blamed on Alisha via e-mail. Alisha was also told by a mutual friend that John has multiple pictures that he obtained from My Space and Face Book hung on his bedroom walls.

John came back around in 2016, when Alisha identified "hundreds" of messages from John. (Alisha attempted to recover the messages and is unable to do so) She explained that in the messages John was following her around and gave precise information about her whereabouts. She stated that John was very angry in the messages and it appeared that he developed a hatred for her and her family. He would talk about his knife collection, Gorilla Warfare, and how he knew how to stalk and hunt people would talk about his knife collection, Gorilla Warfare, and how he knew how to stalk and hunt people down. He begins to address her as a whore and included inappropriate language. Since that time she has deactivated her Face Book account and opened a new one with stricter privacy settings.

John still was able to make contact with her and sent an e-mail which Alisha responded to. Alisha stated that she felt sorry for him and his family and that she advised him that she forgave him for all the wrong he has done and requested that he just leave her alone and wished no further contact from him. Alisha states from that event that his obsession elevated to another level.

John was messaging her on Face Book and via e-mail. His outrageous behavior had highs and lows. He was mad and then happy. She again told him to stop contacting her or she would file a report with the police department.

During 2017-2018 John would continue to e-mail her a couple times a month. He also called her multiple times through Face Book Messenger. He eludes that they were still friends and he believed there was a chance they could rekindle their relationship.

In a post dated November 21, 2017 John sends an offensive e-mail with a picture of a penis. On March 28, 2018 he sent another e-mail with a picture of himself without a shirt on.

In September of 2018 a mutual friend of theirs, Ben Locke filed a report with the Sheriff's Office in regards to John knowing where Alisha worked and was worried that he would show up at her place of employment. Ben tried to explain to John that they (Alisha/John) were not together nor would they ever get back together but John would not get it through his head that the relationship ended in grade school. Ben was very concerned for Alisha's safety.

After this incident Sgt. Jones went to speak with Alisha and dropped off a protection order. She advised her that she should consider getting a Civil Stalking Protection Order.

Alisha did not hear from John for several more months. John showed up at her home unannounced and her boyfriend Nicholas answered the door. John asked to speak with Alisha. Nicholas advised him that she was unavailable and that's when John became belligerent and stated he would go to Alisha's workplace since she wasn't home. Nicholas called 911 and explained the ongoing situation with John. John never showed up at her employer to her knowledge. She explained that she was very scared for her safety so she reached out to John's mother to see if she could talk to him and explain to him that she wants no further contact from him. After Alisha and John's mom had a phone conversation about his behaviors, John must have gotten his mothers cell phone and retrieved Alisha's number from it. Alisha stated that's when she made up her mind to obtain a protection order.

On February 21, 2019 a 911 call came into dispatch in reference to an unwanted guest. The unwanted guest was identified as John Reedy. He arrived at the residence to speak with Alisha Castle. She answered the door because she was expecting company but not from John Reedy. Upon opening the door she was met by Mr. Reedy. John grabbed her arm and forcefully pulled her from the doorway and stated that he needed to talk with her. Alisha yelled for her boyfriend Nicholas Ketchum and he stepped in between John and Alisha. John continued yelling at Nicholas stating that he wasn't going to leave. Nicholas closed the front door and waited for him to exit the property. John walked to his car and proceeded back towards the house yelling and that is when Nicholas went outside to make contact with John. At some point during their contact Nicholas did strike John in the face and tried to keep him pinned to the ground until the sheriff's office arrived. John was able to break free from Nicholas and ran to his vehicle. Alisha stated that John was yelling at Nicholas and stated he would be back to kill Nicholas and made a gesture with his hand of a gun and pointed it towards Nicholas.

John left the residence in his car and was pulled over by deputies and was cited for menacing in reference to Nicholas Ketchum, OVI and multiple traffic offenses.

I am requesting warrants for John Reedy for one count of Assault, one count of Criminal Trespass, and one count of Menacing by Stalking.
