## CONSEQUENCES OF TEST AND REFUSAL (R.C. 4511.192) (MUST BE READ TO OVI / PHYSICAL CONTROL OFFENDER)

"You now are under arrest for (specifically state the offense under state law or a substantially equivalent municipal ordinance for which the person was arrested) operating a vehicle under the influence of alcohol, a drug, or a combination of them; operating a vehicle while under the influence of a listed controlled substance or a listed metabolite of a controlled substance; operating a vehicle after underage alcohol consumption; or having physical control of a vehicle while under the influence. "If you refuse to take any chemical test required by law, your Ohio driving privileges will be suspended immediately, and you will have to pay a fee to have the privileges reinstated. If you have a commercial driver license and refuse to submit to the test or tests you will immediately be placed out-of-service for twenty-four hours; you will be disqualified from operating a commercial motor vehicle for a period of not less than one year; and you will be required to surrender your commercial driver license to me."

"If you have a prior conviction of OVI, OVIAC, or operating a vehicle while under the influence of a listed controlled substance or a listed metabolite of a controlled substance under state or municipal law within the preceding twenty years, you now are under arrest for state OVI, and if you refuse to take a chemical test, you will face increased penalties if you subsequently are convicted of the state OVI."

"If you have previously pled guilty or been convicted of two or more OVI'S, OVIAC's, or equivalent offenses in the previous ten years, or pled guilty or been convicted of five or more OVI'S, OVIAC's, or equivalent offenses in the previous twenty years, or pled guilty or been convicted of a felony of any of the above violations, and you refuse to submit to a chemical test required by law, I am authorized to use whatever reasonable means are necessary to ensure that you submit to a chemical test."

If you refuse to submit to the test or tests you will immediately be placed out-of-service for twenty-four hours; you will be disqualified from operating a commercial motor vehicle for a period of not less than one year; and you will be required to surrender your commercial driver license to me."

### ADDITIONAL INFORMATION FOR OFFENDER

---

#### IMMobilization OR FORFEITURE UPON OVI ARREST (R.C. 4511.195)

If you have previously been convicted of operating a motor vehicle under the influence, OVI, (R.C. 4511.19), or similar municipal ordinance, the vehicle and its identification license plates may be seized. The vehicle may be towed and kept by the law enforcement agency or may be immobilized. The period of time for which the vehicle and license plates will be kept or immobilized may be at least until the initial appearance in court. At the initial appearance the court may order that the vehicle and license plates be returned or released to the vehicle owner until the disposition of the charge. If you are convicted of or plead guilty to OVI, the court may issue an order of immobilization of the vehicle and the impoundment of its license plates, or an order for the criminal forfeiture of the vehicle to the state. If you are not the vehicle owner you must immediately inform the owner that the vehicle and its license plates have been seized and that the owner may be able to obtain the return or release of the vehicle and plates at your initial appearance in court.

---

#### OFFENDERS ARRESTED FOR DRIVING UNDER SUSPENSION OR WRONGFUL ENTRUSTMENT OF A MOTOR VEHICLE (R.C. 4511.203)

If you are charged for driving under an OVI suspension, (R.C. 4510.14), or wrongful entrustment of a motor vehicle, (R.C. 4511.203), the vehicle and identification plates may be seized, and the vehicle may be towed and kept by the law enforcement agency. Any period of seizure will be at least until your initial appearance in court. At the initial appearance the court may order the vehicle returned to you or released to the vehicle owner. If you are convicted of driving under suspension, or of wrongful entrustment of a vehicle, the court may issue an order of immobilization of the vehicle and impoundment of its license plates. Upon a third conviction of wrongful entrustment of a vehicle (R.C. 4511.203), of driving under suspension (R.C. 4510.11), or a municipal ordinance similar to one of the above, the court, upon your conviction may order the forfeiture of the vehicle. If you are not the owner, you should immediately inform the owner that the vehicle and the license plates have been seized and that the owner may be able to obtain the return or release of the vehicle and plates at your initial appearance in court.

#### NOTICE OF SUSPENSION (R.C. 4511.192)

Independent of any penalties or sanctions imposed upon you pursuant to any other section of the Revised Code or municipal ordinance, your driver license or commercial driver license, permit, or nonresident operating privilege is now suspended. The suspension takes effect immediately. The suspension will last at least until your initial appearance on the charge, which will be held within five days after the date of this arrest or the issuance of a citation to you. You may appeal the suspension at the initial appearance before the court that hears the charges against you that resulted from the arrest, or during the period of time ending 30 days after that initial appearance.

**Statement of Facts:**

BWCR was in use.

On October 1, 2020 at approximately 2153 hours I was dispatched to the area of State Route 235 near the City of New Carlisle's North City limits in reference to a reckless driver.

While I was in route, I was advised by dispatch that the reporting party was following the vehicle and advised that the vehicle was traveling north bound on State Route 235/S. Main Street and had just entered the City of New Carlisle. As I was traveling south bound on S. Church Street I was advised that the vehicle had just passed Wot-A-Dog, still traveling north bound, and that the vehicle was on 2 flat tires.

When I was at the corner of S. Church Street and S. Main Street, I observed a smaller blue vehicle traveling north bound that had a missing driver side tire and was driving on the rim and the rear driver side tire was completely flat drive pass my location. The driver of the vehicle was driving on the double yellow lines with his vehicle half on the right lane and half on the left lane. As soon as the vehicle passed my location, I immediately got behind the vehicle and activate my overhead lights with my siren.

The driver of the vehicle was only going about 20 MPH and having a difficult time maintaining control of the vehicle. The driver of the vehicle ignored my lights and siren for a couple of blocks before stopping almost at the corner of S. Main Street and W. Jefferson Street. Once the driver stopped, the driver flung their door open and asked what the problem was? I advised the driver to stay in their vehicle as I approached the vehicle.

When I was standing at the driver side door with the driver door completely ajar, I could smell a strong odor of alcohol coming from within the vehicle and/or the person's body. I questioned the driver if he was alright and he advised yes. I questioned the driver where he was going and he advised home. I questioned the driver where he was coming from and he advised Park Layne. I questioned the driver if he had been involved in a crash and he advised no. I questioned the driver if he knew that he was missing 2 tires and he advised no. I questioned the driver if his vehicle was driving funny and he advised no.

After a few questions the driver of the vehicle seemed to become somewhat irritated with me asking him questions because he asked me why I was asking him so many questions. I advised the driver that I was just trying to figure out what was going on. I questioned the driver for his driver's license and he was identified as Terry L. Farrow. I questioned Terry if he had been drinking and he advised some. I questioned Terry what some

was and he advised a couple beers. I questioned Terry where he was coming from and he advised the bar from Park Layne (D&D Lounge). Terry was questioned if he was having any medical issues and he advised that he used to be a diabetic but no longer.

New Carlisle Medic # 52 was called on scene and Terry was checked. Medics advised that Terry's blood sugar was normal and vitals. Terry did not complain of any pain or advised that he was having any medical issues while the medics where on scene.

After Terry was checked by the medics, I advised Terry I would give him the opportunity to take a Standard Field Sobriety Test and Terry advised that he couldn't do it because he couldn't walk and needed a cane. I advised Terry we could do part of the test right at his driver's seat which was an eye test and Terry questioned what I wanted to do that would make me happy. I advised Terry it was not about me and this was all about him. I offered Terry several times part of the SFST while taking in consideration his disability he was advising and the need of a cane to aid in walking but Terry would only question what was being requested of him. Terry was advised by me, Deputy V. Apel, and Deputy Z. Storts of the eye test portion of the SFST and he would only question what we wanted him to do. Terry advised me that he really didn't care and would rather be taken to jail.

Terry was arrested for OVI (Citation # 299223). Terry was read the BMV 2255 form and was witnessed by Deputy Apel which Terry refused to sign. Terry's vehicle was towed (Towed # 20-55868) by New Carlisle Auto. While arresting Terry he advised us to shoot and kill him. Terry advised that he has wanted to die for some time now since he was dying.

Terry was transported to the Clark County Jail where he also refused to take a breathalyzer test. Terry was cited for OVI refusal, expired driver's license (7/11/2018), no driver's seat belt, left of center, and fictitious plates (Citation # 299223). Terry was kept at the Clark County Jail due to unable to locate anyone to pick him up or assume responsibility of Terry. Terry was also placed on suicide watch due to making comments on suicide. Terry was given a court date of October 2, 2020 at 1030 hours.

Deputy Apel spoke with the reporting party and advised me that he was advised that Terry had cut off the reporting party coming out of the Park Layne IGA shopping Center. Deputy Apel advised me that the reporting party advised him after he was cut off that Terry drove over the concrete median that separates the incoming and outgoing traffic and that he blew both of his driver side tires. Deputy Apel advised me that the reporting party advised him that Terry continued driving all over the roadway on State Route 235 and that several motorists attempted stopping him but he just kept going. Deputy Apel advised that the reporting party advised that Terry had also gone off the roadway and some points before he was stopped.
