**Complaint By Individual:**

Before me, a Notary Public for the State of Ohio, a Peace Officer authorized to administer oaths or Clerk of the Clark County Municipal Court of Springfield, Ohio came Trooper Bradley Baker who being duly sworn states that on or about August 22, 2023 one Hermanio Joseph in the Township of German, Clark County, State of Ohio did:(A) No person, while operating or participating in the operation of a motor vehicle, motorcycle, snowmobile, locomotive, watercraft, or aircraft, shall cause the death of another or the unlawful termination of another's pregnancy in any of the following ways: Negligently


**TO WIT:**

*On August 22, 2023, at approximately 0812, troopers from the Ohio State Highway Patrol were dispatched to a two vehicle crash involving Northwestern School Bus #14 and a Mini Van. The bus was occupied by 52 students and one driver. After troopers arrived on scene, it was learned the crash resulted in the fatality of one of the students. 26 students were transported to local hospitals with injuries ranging from major to minor. The driver of the van was identified by his Ohio Identification Card as Joseph Hermanio. Mr. Hermanio also produced a License from Mexico which was determined to be not valid due to his immigration status. The crash was a result of Mr. Hermanio driving left of center, striking the school bus, forcing it off the roadway, down an embankment where it overturned and came to final rest.*
