

The Affiant, Deputy B. Ballentine , being first sworn, says there is probable cause to believe the defendant, Jerry D. Varney , committed an offense based on the summary of facts below:

Your Honor,

BWCR # 77 and #86

On 2/19/2024 at 1121 hours,

Reportee - I wanted speak to deputies in reference to her ex-boyfriend and father of her three (3) children, Jerry Varney changing a profile photograph on both his google email / instant messenger and his XBOX account to pictures that she firmly believes are hidden messages to her and her children, who are protected from Jerry Varney under TPO: #24DP0038.

-- - stated that she has eliminated all contact from Jerry. But she has in her google email / instant messenger account his email account and messages at plain view from prior to filing for a protecting order. Ms. Dean stated that she had noticed his profile photograph had changed and has continued to changed since after filing for a protection order. She further advised that prior to the protection order he had not changed either profile photograph in three (3) years. She also further explained that the profile photographs were photographed comments that she believes are direct messages from Jerry.

Messages such as:

"Happy Valentine's Day, Love you Always and Forever"

"Happy Valentine's Day, Love you always and forever, you are appreciated"

"I promised I would always take care of U, I'm going too"

"I would never let you go no matter how bad the situation is"

" I want u, I want us, I want it all with u only"

"Don't give up on us baby, I will never quit on you, your my world and all I wanna do is give you the love and attention that you deserve"

"When we first met I accepted you and everything that came with you, I promised you I would always provide and care for you and I meant that so therefore, it is my duty to take care of you for the rest of our lives. I love you always and forever"

I explained that her two younger children have an XBOX in their room which they use from entertainment applications such as Youtube TV, Netflix, Disney+, etc. Ms. Dean stated that it was her understanding that she should not change her or her children's daily routine for example, the use of TV and XBOX. _____ stated that her children's XBOX is signed into Jerry Varney XBOX user account. She described her routine is that the XBOX is always signed and being able to use Youtube TV for the children to be able to watch certain programs. With this being said, _____ feels that her protection order is being violated because like the email / instant messenger she noticed that Jerry had changed his XBOX profile photograph to a picture of a hidden but direct message to her and her children. She describes Jerry as trying to be clever, thinking law enforcement won't see this as a violation.

_____ stated that she took pictures on her phone of these hidden messages and profile changes, which she will forward to my email. I advised Ms. Dean that I will communicate with the Prosecutor's Office and Sgt. Jones (Victim Advocate) about charges.

On 2/23/2024 at 0700 hours,

After returning to start my work week, I received emails from both Sgt. Jones (CCSO) and the reportee / victim I _____ In those emails were the photographs I had requested from _____ on the day I took the initial report. After collecting my evidence, I believe this is a violation of protection order #24DP0038 which was served to Jerry Varney on 1/31/2024 1659 hours by Deputy Hartsell (CCSO).


