

The Affiant, Officer Malone, being first sworn, says there is probable cause to believe the defendant, Dayton Allen Prince, committed an offense based on the summary of facts below:

On 03/17/2024 at 1847 hours, Officers were dispatched to the Executive Inn located at in reference to a assault.

Upon arrival, Officers spoke with the mother Tanya Prince. Ms. Prince stated her older son Dayton Prince came to pick up her 14 year old daughter to take hang out with him. Ms. Prince stated she told her daughter she could not go because Dayton and his girlfriend are not good influences. Ms. Prince also advised Dayton and his girlfriend were advised by Executive Inn staff that they were not allowed to be on the property.

Ms. Prince advised after she told her daughter she could not go, Ms. Prince overheard her daughter speaking with Dayton on the phone who was advising her that he would meet her at the Rite Aide across the street to pick her up. Ms. Prince advised she told Dayton he was not allowed to come get her daughter and Dayton responded to her "I'll do what I want, she's my sister." While Ms. Prince was yelling at her daughter because of her being unruly and not listening to her, the employee Melinda Stevens came to the door to tell her to keep it down. Ms. Prince advised Ms. Stevens of why she was yelling and notified Ms. Stevens that Dayton was coming to the property and he is not allowed to be here.

Ms. Prince advised approximately 5 minutes later, her 14 year old daughter went out the door of the apartment and started to go out of the Executive Inn. Ms. Prince advised began to run down the stairs after her daughter to stop her from going and disobeying Ms. Prince's orders. Ms. Prince advised once she was downstairs and outside of the Executive Inn, Ms. Stevens was already in a verbal argument with two unknown females. Ms. Prince advised Ms. Stevens was telling them they were not allowed to be on the property, which started to argument between Ms. Stevens and the two unknown females.

Ms. Prince stated the argument started at the front of the Executive and then moved over to the street to the west of the Executive Inn, N. Plum Street. Ms. Prince stated Dayton then drove a blue Chrysler (JZL5810) from behind the Rite Aide over to N. Plum Street where he back it into a driveway just west of N. Plum Street and exited the vehicle. Ms. Prince stated was attempting to keep her daughter from leaving with Dayton and which started a argument between and his brother, Dayton. Ms. Prince stated during the argument, Dayton began to strike in the face approximately three times. Ms. Prince stated once of the unknown females wearing a dark colored hooded sweatshirt with dark hair came up and struck Ms. Stevens in the face one time before the two females and Dayton got back into the blue Chrysler and left the scene.

Ms. Prince advised was upset and left before medics arrived at the scene. Officer Turner took photos of injuries. Ms. Prince completed a witness statement while Officers were on scene.

A warrant for one count of Domestic Violence and one count of Assault are being requested for Dayton Prince due to the incident.






