

The Affiant, Detective Nicholas Moody , being first sworn, says there is probable cause to believe the defendant, Glen J Sexton , committed an offense based on the summary of facts below:

On March 24th, 2024, I received a call from Lieutenant Shultz in reference to a shooting that occurred at 204 Slayton Street. Lieutenant Shultz stated Detective Melchi would be going to the hospital while he and Detective Cultice would be going to the scene. Lieutenant Shultz requested I respond to the office to start on interview's or any other paperwork.

When I arrived to the office I was informed that the victim was pronounced deceased at the hospital. Detective Melchi identified the victim as 48 year old _____ of New Carlisle, Ohio. I was advised that an altercation began in the driveway of 204 Slayton Street between _____ and Glen Sexton. During this argument it was reported that Glen Sexton retrieved a handgun from his vehicle and shot _____ in the abdomen. Bethel Township arrived son scene and transported _____ to the Enon Emergency Room where he would be pronounced deceased at 2220 hours.

Deputies O'Brien and Derringer, transported Glen Sexton and a witness Amas Abdella to headquarters. Almas was placed in interview room number one. Glen was placed in interview room number two. Detective Cultice and I began to interview Almas in reference to the incident. Amas stated she met Glen 10 days ago. She stated she paid him to take her to and from work. Today she stated Glen took her to work around 0800 and picked her up at 1400. She stated they then went back to her apartment at 1836 Cedar Village North where they remained until approximately 2000 hours. Amas stated Glen had been telling her for hours that he needed to pick up _____. Amas advised when they arrived to 204 Slayton Street to pick up _____ he did not come out of the house for several minutes. She advised they decided to go to the store on Lemay Street while they waited. Amas advised when they returned to the residence on Slayton, _____ had still not come out of the residence. Amas stated they waited about another five minutes before _____ came outside and got into the back seat of the Cadillac. Amas advised _____ was always paranoid around her and she believed that he thought she was a "Cop." Amas stated Glen was backing out of the driveway and as he began to drive down the road _____ asked Glen why he was going this way. She advised Glen told him because it was easier to back out this way. Amas stated _____ got out of the car and began walking back toward the front door of 204 Slayton Street. Amas stated Glen, pulled back into the driveway and exited the vehicle. She advised Glen was upset because he wanted _____ to pay him for driving all that way and waiting on him. Amas advised a verbal confrontation began between Glen and _____ next to the Cadillac. Amas stated Joseph got up in Glen's face and Glen got inside of the Cadillac and grabbed his pistol. Amas stated Glen "cocked" the pistol and then _____ punched Glen. Amas stated she then heard a gunshot. Amas stated she began to record the incident but stopped to call 911. Amas stated _____ went to the front door and began knocking but no one answered. Amas stated she then began to render aid to _____

Detective Cultice and I then began to interview Glen Sexton. Glen stated this morning he took Amas to _____


work and then went shopping with his aunt. Glen stated he picked Amas up around 1415 hours and they went back to her apartment. Glen advised around 2000 hours he and Amas went to 204 Slayton to pick up . Glen stated 204 Slayton Street is were his uncle lives. He advised is staying at this address and considered a family friend. Glen stated when they arrived at the residence took a long time to come out of the house. Glen stated once finally came out of the residence he got into the back seat of the vehicle. Glen stated he began to back out of the driveway when asked him why he was going the way he was. Glen stated he told it was easier for him to back out. Glen advised at this time exited the vehicle and walked back to the residence. Glen advised he pulled back in the driveway and got out to talk with Glen advised charged at him from off the front porch and threatened to "beat his ass." Glen advised he felt scared but when we got to the point when the firearm came into play he would stop talking. Glen would then invoke his right for legal counsel.


After this interview Glen was charged with murder and booked in the Clark County Jail.
