The Affiant, Officer J Lowe , being first sworn, says there is probable cause to believe the defendant, Brittany N Whiting , committed an offense based on the summary of facts below:

On March 28, 2024 at 03:45 hours, officers were dispatched to 1831 Woodward Ave, on a report of a domestic violence incident. When officers arrived on scene, Officer Lowe met with _____, who was standing on the sidewalk near the front of her house. _____ appeared to be upset, she had visible redness to the right side of her face. _____ also had a small mark near the bottom of her lip. _____ advised she was just assaulted by her mother, Brittany N Whiting who just returned home from a night of drinking alcohol. At the same time, officers on scene spoke with _____ spoke with Officer Crone at the same time who said she was inside her house with her sister _____ when their mother returned home with her boyfriend. Both _____ and _____ said when they looked outside near the driveway, they saw their mother arguing and fighting with her boyfriend. Ms. Whiting was attempting to assault her boyfriend when they looked outside the window. _____ advised that's when they decided to lock the front door an in attempt to keep their mother from entering the house while being drunk.

Ms. Whiting began to kick the front door attempting to gain access into the house. After several failed attempts, she made her way into the house through a window. Once inside the house, Ms. Whiting began arguing with her daughters, where she stated she was going to leave and drive drunk. _____ said she took her mother's keys, throwing them into the bush outside of the home near the front door. After arguing inside, the argument led outside where Naveah was going to attempt to find the keys to her mother's vehicle. _____ also went outside at this time to assist. Brittany became upset outside after calling her daughter _____ "Bitch," and her daughter cussing her after this statement. _____ said that's when their mother attacked _____ on the front porch, striking her in the face, and placing her in a head lock, _____ also attempted to fish hook her by the mouth. This caused visible injuries to _____ . Officers could visibly see blood near her mouth, redness to her face and she was visibly crying over this incident. During the incident on the porch, _____ attempted to stop her mother, where she was struck in the right side of her face, and lower lip. _____ advised her mother pushed her down a set of concrete steps, this caused her to have an injury to her right knee.

After talking with both _____ on scene, they wanted to press charges on their mother for domestic violence and assault. Officer Lyons and Householder placed Brittany N Whiting under arrest, placing her in a patrol vehicle #36. Brittany Whiting was placed in the Clark County jail where she was charged with two counts of domestic violence and two counts of assault.

Both _____ wrote a short DV statement of facts on scene and were provided with a case number for this incident. Brittany Whiting was given a court date of March 28, 2024 at 10:30.
