



The Affiant, Deputy Michael Garman, being first sworn, says there is probable cause to believe the defendant, Johannes Gerhardus Assen, committed an offense based on the summary of facts below:

Your Honor,

**BWCR** 

On May 9th, 2024 I was dispatched to 774 S. Houston Pike in reference to a domestic between a live in boyfriend and live in girlfriend. Reporting party Johannes Assen called in reference to his girlfriend coming over and refusing to leave. Johannes advised she was getting confrontational with him and was intoxicated. While enroute, dispatch advised called in and advising Johannes had a firearm and was leaving the residence walking towards the pole barn on his property.

Deputies arrived on scene at 774 S. Houston Pike and turned on our flood lights from our cruiser onto the pole barn. A guest house which was located to the right of the pole barn as you approach and deputies observed shouting to deputies for help. advised he was last seen going into the pole barn with a 9mm handgun. Deputies tried multiple times on our loud speaker mic from inside our cruisers to have Johannes exit the pole barn and put down any firearm he had. Several times deputies did this and no one answered back to us. A short time later, dispatch received a call from Johannes after we advised dispatch to contact him by phone and have him come out and speak with us. Dispatch advised to deputies Johannes told them he had left the property and was no longer there. Prior to our arrival on scene dispatch informed deputies that Johannes had a statewide pick up warrant through Delaware County. The warrant was for Violation of a Court Order (Case Number: 24CRB00353).

After multiple attempts at trying to get Johannes to come out of the pole barn and discovering that he might not be on the property, Deputy Harris and I went to the guest house to make contact with was in a high emotional state and advised she had been drinking also. advised to me that she and Johannes were drinking tonight and he was upset because he had court today in reference to his divorce from his wife.

advised Johannes found out at court today that part of his divorce ruling was for him to sell his land at 774 S. Houston Pike where he resides. advised Johannes was drinking rum and coke and the two got into an argument. Johannes during the argument shoved her against the wall calling her trash and told her to leave multiple times. When refused to leave due to her having her dogs, bird animals, and belongings there she advised to me Johannes got a 9mm handgun out and point the handgun at her in a threatening manner. Johannes then left the guest house and left towards the pole barn according to advised she had been living in the guest house with Johannes for the past six months since he and his wife divorced. I advised hat he told our dispatch that he is no longer at the residence and she advised that if he had left he would have left in a black Chevrolet High Country pick up truck. Deputies observed the black Chevrolet pickup truck still in the pole barn.

Deputy Harris and I both spoke with about her leaving the guest house. advised to deputies that she had an apartment in Northridge at the Northridge Apartments. Deputies advised to we would take her to the apartment. at first refused deputies helping her and said she would stay but then changed her mind and took her dog, parrot, and belongings. Deputy Harris drove her to 1604 Westmont Ave. and I followed.

While enroute, Johannes called our dispatch and they forwarded him to me. I spoke with Johannes who wanted to know if the property of the property. I advised Johannes the property with deputies but I wanted to meet with him to discuss the events of tonight. Johannes refused to meet and refused to give a written statement about what had happened. Johannes just informed me they was intoxicated and they had been arguing and he told her to leave and she refused to leave. I advised Johannes that they refused to different story about the events of what happened tonight. I Mirandized Johannes on the phone and asked if he understood but refused to give verbal confirmation if he understood after asking him several times if he understood. I advised Johannes that they made the statement that he had pointed a firearm at her and that he shoved her. Johannes advised it was not true and that he didn't have a firearm. I advised Johannes that I would like to meet with him to get his statement about the events that happened tonight but refused to meet me due to him having a warrant that Jennifer advised he knows about.

Once Deputy Harris and I arrived at 1604 Westmont Ave. I asked r if she would like to complete a written statement of the events that occurred tonight that she had verbally told me about. refused to complete a written statement and all DV related agency forms advising she will complete them tomorrow when she has sobered up. I gave her a DV packet with the case number to reference to and advised her the packet contains ways to obtain a protection order. advised she was aware of where she needed to go to complete a protection order. I advised to her if she was wanting us to contact an on call advocate from Project Woman and she refused to speak to an advocate from Project Woman advising she knows an advocate from Project Woman and would speak to her on the matter. I advised someone from our domestic violence unit will reach out to her for follow up.

Due the verbal statement from in reference to Johannes shoving her and pointing a firearm at her, I will be filing warrants for Domestic Violence, Assault, and Aggravated Menacing. A CCH was ran on Johannes for prior Domestic Violence, Assault, and Aggravated Menacing with no prior convictions.
