





The Affiant, Deputy S. Harris, being first sworn, says there is probable cause to believe the defendant, Eric C Frank, committed an offense based on the summary of facts below:

Your Honor,

On June 15, 2024 I was dispatched to a call at 4357 Grange-Hall Rd in reference to a threats call. Upon arrival I spoke with _____ who advised she has been married to Eric Frank for 15 years but they separated 2 months ago and she is going to file for divorce. She advised she found out a week ago Eric has been homeless so she paid for him to stay at the Fairfax motel in Springfield for a week but his week was up today. She advised she refused to pay for the hotel any longer and Eric has been calling multiple times a day everyday for the past week threatening her sister and her husband and leaving inappropriate voicemails on her answering machine. _____ advised I could listen to the 22 voice messages that she had saved on the voicemail. While attempting to listen to the messages Eric continued to call the phone. I advised _____ to answer the telephone and explain to Eric if he called the phone again he would be charged with telecommunications harassment which she did. Eric then called the phone again this time I answered the phone and advised Eric he would be charged with telecommunications harassment, Eric then called back 5 more times none of those calls were answered.

I spoke with _____ who advised Eric has continued to call the phone multiple times and has threatened to kill her and her husband. _____ advised she was willing to fill out a witness statement and a domestic violence probable cause statement. I collected the paperwork and left the scene to meet SPD on their call where they had Eric Frank at the Fairfax motel for a call unrelated to mine. Eric was taken into custody and I transported him to the Clark County jail where he was transferred into their custody.

I ran a CCH on Eric and it came back negative, I _____ was given a DV packet with a case number for her records.
