The Affiant, Officer C. Johnson, being first sworn, says there is probable cause to believe the defendant, James Troy Allen, committed an offense based on the summary of facts below:

On June 16th 2024 Officers Underwood and C. Johnson were dispatched to 1305 Selma Rd in reference to a Burglary.

Officers arrived on scene and spoke with _____ stated that Troy Allen had showed up at her home and asked to mow her grass for \$20.00. I advised that she agreed with this request and Mr. Allen completed this task. After mowing grass, allowed Mr. Allen to enter her home for a glass of water. When Mr. Allen returned, told officers that Mr. Allen requested to stay here. This request was denied by At this point Mr. Allen became irate with _____ and started screaming at her. then entered her home and locked the door and went into a separate room to avoid Mr. Allen.

At this point _____ observed Mr. Allen inside her home and told officers he said that the locked door would not stop him. _____ stated she was in the process of calling 911 when Mr. Allen attempted to take her phone from her to prevent her from calling authorities. _____ told officers she had to call from a separate phone in order to contact 911.

Officers observed security cameras at the front door of the residence here that was unplugged. Officers questioned _____ on this and she had no idea when that would have happened. Officers also asked how Mr. Allen could have gotten in, she stated she did not know because she always locks her doors and windows. _____ then realized that one of her front windows was opened and unlocked during the investigation. She did not remember opening this window and believes Mr. Allen had unlocked it when he came in for a glass of water in order to gain entry into the home at a later time. _____ told Officers that Mr. Allen does not live here and does not have any belongings inside her home.

_____ stated that Mr. Allen was around 6'0 tall and gave the birthday of 9/16/72. Officers were able to locate James Troy Allen through LEADs.

Warrants have been requested on James Troy Allen for Burglary, Robbery and Disruption of Public Services.
