The Affiant, Off McCutcheon, being first sworn, says there is probable cause to believe the defendant, Brandi McDaniel, committed an offense based on the summary of facts below:

On this date Officers were dispatched to the IOOF Home at _____ in ref to the defendant, Brandi McDaniel, assaulting staff and refusing to follow directions causing disruptions. Upon arrival Officers spoke with the victim, _____ is a nurse at the long term care facility in the behavioral unit where Defendant McDaniel is housed. On this date according to Ms. _____ Ms. McDaniel was already yelling at and threatening other residents of the facility. Ms. _____ decide to take Ms. McDaniel outside to smoke to remove her from the situation that she was causing. Upon completion of her cigarette, Ms. McDaniel refused to go back inside the facility. Ms. _____ got out her phone to call other staff for assistance. Ms. McDaniel attacked _____ slapping the phone into _____ face. Ms. McDaniel pushed _____ into a wall and began slapping _____ with an open hand multiple times. _____ was finally able to signal to other staff for help and they were able to separate the women.

Ms. McDaniel was seated in a chair when officers arrived. After sorting out what happened and speaking with witness, Tina Deters, the director of nursing, Officers advised Ms. McDaniel that she was under arrest and need to stand up. Ms. McDaniel clenched her arms tight to her body, She was advised that she was going to be charged with Resisting if she didn't stand up and release her arms. To which she stated "I'm not going to jail and I'm not going to court, even with a subpoena."

Officers were able to secure Ms. McDaniels hands with handcuffs and had to lift her from the chair due to her passive resistance. Ms. McDaniels was taken to police headquarters where she was charged with one count each of Assault and Resisting Arrest. She was placed in the Clark County. _____ had visible signs of injury at this time and declined any medical services.
