

The Affiant, Officer Malone, being first sworn, says there is probable cause to believe the defendant, Jeffrey Lee Strodes Jr, committed an offense based on the summary of facts below:

On 07/09/2024 at 0125 hours, Officers Malone and Chenoweth responded to a emergency tone for a male in a blue Jeep at McDonalds located at 2328 E. Main Street that popped the Rp's tires and had a gun.

Upon arrival, Officer Malone and Chenoweth made contact with the reporting party, Brittnie McConnaha. Ms. McConnaha advised that a male by the name of Jeffrey Strodes had taken money from her girlfriend while they were in the drive thru of McDonalds then produced a knife and popped both tires on the drivers side of the black Trail Blazer (KHU3165) owned by a Megan Snapp.

stated she was just about to order when Jeffrey Strodes arrived in a blue vehicle and pulled in front of her vehicle stated Mr. Strodes got out of the vehicle and approached the drives side window and told her "Give me your money" and began reaching in the vehicle in an attempt to grab her brown purse. advised after a short wrestling match over the purse, Mr. Strodes was able to grab the money from inside the purse stated she tried to grab the money from his hand causing the money to rip. advised the money consisted of one twenty dollar bill, six five dollar bills, and two or three one dollar bills totaling 52.00 to 53.00 dollars in US currency. Ms. \_\_\_\_\_ advised Mr. Strodes then produced a knife and punctured both drivers side tires causing them to go flat. Mr. Strodes then left the scene in the vehicle he arrived in. A plate registration of (KGQ6567) was given for the vehicle Mr. Strodes left in. The vehicle registration came back to a gold 2008 Jeep. Officers asked how she know Mr. Strodes and she advised she does not know him very well but is a friend to her. advised she has helped him in the past but was never in a relationship with Mr. Strodes.

Ms. McConnaha advised Officers a male in a blue Jeep had pulled in front of her girlfriend's vehicle while they were in the drive thru at McDonalds located at 2328 E. Main Street. Ms. McConnaha advised the male got out of the vehicle and approached the drivers side the black Trail Blazer she and were in at the time of the incident. The male began to grab \_\_\_\_\_ purse and took her money from the purse before coming back and snatching money from Ms. Simcox's hand. Ms. McConnaha advised the male then took a knife and slashed the tries on the vehicle. Ms. McConnaha advised they got into a verbal argue as \_\_\_\_\_ was pulling the vehicle into a parking spot. During the argument, Ms. McConnaha advised the male told her "I will pop you" and Ms. McConnaha told him to go ahead and do it. The male then got into his vehicle and left the scene. While asking Ms. McConnaha about the firearm that was mentioned to dispatch, Ms. McConnaha advised Mr. Strodes never produced a firearm at McDonald's but did have him hands in his pocket while approaching the vehicle in the drive thru. Iso advised she never saw a firearm on or in Mr. Strodes hand during the incident. Officers asked Ms. McConnaha how she knew Mr. Strodes and she advised she doesn't really know him and only knew his name because of

Officer Melcvin was able to locate a blue Jeep Nitro pulling into the address of 127 E. Cecil Street. Officer Melvin was able to get the vehicle to stop to the rear of the vehicle. Mr. Strodes was found to be driving the vehicle. Mr. Strodes was detained and Officer Melvin read Mr. Strodes his Miranda Rights before any questioning in reference to the crime. Officer Chenoweth advised Officer Melvin that Mr. Strodes will have charges of Aggravated Robbery and Criminal Damaging. Officer Melvin then transported Mr. Strodes to police headquarters. Officer Melvin only located a lightner, a phone, keys, a pack of black and 60.00 dollars in Us currency on Mr. Strodes at the time of the traffic stop.

While sitting in the work room of police headquarters Mr. Strodes advised Officer Chenoweth that he was at McDonalds at 2328 E. Main Street. Mr. Strodes stated he gave money to go to Walmart. Mr. Strodes advised he got a call while was gone that she was at McDonalds on E. Main Street with her ex girlfriend Brittnie. Ms. Strodes advised he drove up there to get his money back from her because he did not want her to be spending his money on her ex girlfriend. Mr. Strodes stated he told o give his money back while she was at McDonalds. Mr. Strodes stated he was able to get his money back from after arguing with her. Ms. Strodes stated Brittnie was yelling at him the entire time and eventually called the police. Mr. Strode advised Officer Chenoweth her did puncture the tires of the vehicle during the incident. Mr. Strodes also stated Ms. Simcox told him to leave so that he would not get in trouble.

Officer Chenoweth took photos of the scene. Officer Chenoweth also spoke with who is the owner of the vehicle that was damaged. Ms. Snapp advised Officer Chenoweth she did want charges on Mr. Strodes in reference to the damages. Officer Malone had both Ms. McConnaha an completed a written statement for the incident. The 60.00 dollars was submitted to property under property receipt number 33554.

Sergeant Slusser was able to speak with the manager of McDonalds Takesha Compton. Ms. Compton advised she did not see the incident but did see a blue car pull up before hearing a male yelling "give me your money" in the drive thru while a female was at the drive thru speaker.

Mr. Strodes was booked and placed in CCJ with one count of Aggravated Robbery and one Count of Criminal Damaging. Mr. Strodes court date will be 07/09/2024 at 1030 hours.
