The Affiant, Officer J. Perilman , being first sworn, says there is probable cause to believe the defendant, Carrie Ann Powers , committed an offense based on the summary of facts below:

On Tuesday, July 9, 2024, at approximately 1130 hours, Officers Barger and I were dispatched to _____. regarding a trespassing complaint. The reporting person, _____ called because an intoxicated woman who had been kicked out of the program was refusing to leave the premises.

Before our arrival, the Springfield Fire Division arrived and checked on the suspect. They cleared the scene before our arrival, informing dispatch that there was no medical issue with her. We arrived and met with _____. She said that she had asked the woman, who was still sitting on the ground in the parking lot, to leave, but she refused. _____ requested that we removed the suspect and completed a no trespass letter on her.

I spoke to the woman, who was sitting next to a half-consumed bottle of vodka. Her speech was slurred, and there was an odor of an alcoholic beverage on or about her person. I asked her for her name, but she asked me why I needed it. I explained that I was investigating a criminal trespassing complaint, and that it was needed for the no trespass letter. I asked her several more times for her information, but she still refused to and argued the reasoning. Officer Barger asked her if she was willing to get up and simply leave, but she also refused to do that.

After several attempts, Officer Barger informed her that she was under arrest for criminal trespassing. I told her to stand up and place her hands behind her back, but she kept arguing with me. I told her several times that if she did not stand up, that I would stand her up. I asked her to do so on her own, but again she refused to. Officer Barger and I stood her up by her arms and continued to tell her to put her hands behind her back, but she tried to place them in front of her. We had to turn her arms back against her pressure in order to handcuff her.

We attempted to walk her to our patrol cruiser (Car #54), but she began acting as dead weight. We had to pull/walk her along until we got to the cruiser. Once there, I noticed that she was wearing a hospital bracelet on her right wrist. Through that and a later records search on the in-car computer, I was able to identify her as Carrie Powers.

We opened the rear door of the cruiser and told Ms. Powers to sit on the seat, but she once again refused to listen or comply with our commands. We were able to get her halfway into the cruiser, until Officer Barger had to go to the other side of the cruiser and pull her into the back seat as I pushed her. After this, we were able to get her secured into the cruiser.

Dispatch informed us that Ms. Powers had an active warrant for failure to appear for criminal trespassing. Before leaving, Officer Barger completed a no trespass letter, which _____ signed. We transported Ms. Powers to the Clark County Jail, where she was booked in on charges of criminal

trespassing, obstructing official business, resisting arrest, and her active warrant.

Ms. Powers' personal items were stored in the sally port for safekeeping due to the jail's intake policy.


