The Affiant, Deputy Justin Derringer, being first sworn, says there is probable cause to believe the defendant, Ethan Erin Louk, committed an offense based on the summary of facts below:

BWCR

On 7/15/2024, deputies responded to 307 S. Church Street, New Carlisle, Ohio, 45344, on a wanted person complaint. The wanted person was identified as Ethan Louk aggravated menacing, obstructing official business, failure to disclose personal info, and disorderly conduct through Springfield Police Department. I checked Mr. Louk's Ohio Identification card on my computer as I arrived on scene. Upon our arrival _____ went around behind the house in the alley. I approached the front door and knocked. A male subject cracked the door open to where I could see his face. The male subject was identified as Mr. Louk. I asked if his name was Ethan. I advised him he had a warrant. I radioed that I had Mr. Louk at the front door and asked if we could check on the warrant.

_____ responded to the front door from behind the house. As he arrived at the front door, I was talking to Mr. Louk in the door way. Mr. Louk was asked if he knew he had a warrant. Mr. Louk responded for who. I advised him it was for Ethan. Mr. Louk advised he was going to go get his ID but, we advised him to stay with us. I moved more into the doorway. Mr. Louk asked how we knew it was for him. I advised him I looked at his BMV photo prior to coming to the house. Mr. Louk stated for what. Mr. Louk was advised we get a list of everyone that has warrants and check on them. Mr. Louk was explained we have to confirm the warrant. Mr. Louk had advised us to wait outside while they check on the warrant. We advised Mr. Louk we are not going to wait outside. Mr. Louk stated we are not coming inside. Mr. Louk advised me to move my foot out of the door. Mr. Louk attempted to close the door. I went to grab hold of Mr. Louk to detain him while we waited on confirmation of the warrant. Mr. Louk immediately grabbed me and started to resist. _____ also took hold of him and attempted to assist in getting him detained. We struggled with Mr. Louk out on to the front porch. Dispatch was radioed that we were fighting one. He was advised to stop resisting but continued to resist. _____ and I kept attempting to get him on the ground. I attempted to get him off balance by pick up a leg of the ground. _____ I advised me to hold up.

_____ attempted to use his body weight to pick him up and place him on the ground. Mr. Louk used his body weight and pushed _____ off the porch into the grass toward the South side of the front of the house while _____ was in a hold with him causing an ankle injury to _____ I lost my hold when that occurred. My glasses also went flying off onto the porch when that happened.

_____ and I were able to get him on his stomach but was refusing to place his hands behind his back. _____ and I used our body weight to keep him on his stomach. Mr. Louk was advised to place his hands behind his back or he would be tased. Mr. Louk was advised to bring his hand back nice and easy. Mr. Louk headbutted _____ Mr. Louk took hold of my right leg. I was able to break his hold on my leg and was able to get a handcuff on his right wrist. We were unable to get the second handcuff on. Dispatch was advised he was still fighting us but, we had one handcuff on. We attempted to get his hands behind his back together but, he was refused. _____ administered one drive stun to Mr. Louk's lower back. We were able to get both his hands behind his back. I took

out a second pair of handcuffs and was able to secure Mr. Louk. Dispatch was advised Mr. Louk was detained at this time. A medic was requested to look at

Deputy Hartsell arrived to assist. Deputy Hartsell and I placed Mr. Louk on his feet. Mr. Louk attempted to go dead weight. Mr. Louk was advised to stand up. We were able to get him to the Deputy Hartsell's cruiser. Deputy Hartsell searched Mr. Louk person incident to arrest. Mr. Louk refused to get into the backseat of Deputy Hartsell's cruiser. Deputy Hartsell and I attempted to place him into the backseat of the cruiser but, Mr. Louk placed his feet onto the sides of door and door frame preventing him from going into the cruiser. Deputy Hartsell and I placed onto the ground to regroup. Mr. Louk was advised he was going to get into the backseat of the cruiser. Mr. Louk was also advised he was still resisting. We were able to pick him up and placed him into the backseat as Mr. Louk continued to struggle against us. I was able to close to the door.

Medic 52 arrived to render aid. was evaluated and transported to Springfield Regional Medic Center for further evaluation and treatment. Mr. Louk was also evaluated for any injuries and for the drive stun. Mr. Louk refused to speak with medical personnel.

Deputy Hartsell transported Mr. Louk to the Clark County Jail. Deputy Harris took photographs of injuries and the scene of the incident.

Mr. Louk was booked into the Clark County Jail on the above warrants. Mr. Louk will also be charged with assault on a peace officer, obstructing official business, and resisting arrest. He will be given a court date of 7/16/2024 at 1030 hours.


