STATEMENT OF FACTS

On July 20, 2024, at approximately 0110 hours, I was turning left (eastbound) onto McCreight Avenue from Limestone Street in the city of Springfield, Clark County, Ohio. I observed a 2019 black Kia stopped at the traffic light. I observe the Kia was stopped well beyond the white stop bar, nearly in the pedestrian crosswalk. I turned around to initiate a traffic stop.

Upon passenger-side contact, I explained the reason for the stop to the driver, identified as Brandon Tyler Short. While talking with Mr. Short, I detected a moderate odor of an alcoholic beverage coming from within the vehicle. I observed Mr. Short's eyes were glassy. With the vehicle off, I walked around to the driver side of the vehicle and requested Mr. Short exit. As Mr. Short was getting out of the vehicle, I observed an open can of beer in the driver's door cupholder. I felt the beer was cold to the touch. I advised Mr. Short to dump the open container out.

Once out of the vehicle, I asked Mr. Short if he had anything illegal on him, and he expressed that he had marijuana on him. A consensual pat-down was completed. I sat Mr. Short in my patrol car. While in my patrol car, Mr. Short stated he "hit the stop sign then pulled up." Mr. Short further stated the traffic light was about to turn green, so he pulled up. While talking with Mr. Short, the odor of an alcoholic beverage was still noticeable. I explained my observations to Mr. Short and asked how many alcoholic beverages he has consumed. Mr. Short stated a few drinks. When asked, Mr. Short advised he smoked marijuana earlier and expressed his eyes are bloodshot because he was tired. Before beginning any standardized field sobriety test, I asked the premedical questions. Mr. Short denied wearing contact lenses, glasses, or taking any prescribed medications. Mr. Short consented to participate in a standardized field sobriety test.

Horizontal Gaze Nystagmus Test: Due to Mr. Short's height (6'4"), I requested he squat on the front passenger quarter panel. I placed the tip of my ink pen (stimulus) approximately 12–15 inches from Mr. Short's face. I observed his pupils were equal in size and no resting nystagmus was present. I instructed the test to Mr. Short; when asked, he stated he understood the test and had no questions. During the test, I observed a lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and the onset of nystagmus prior to 45 degrees. No vertical nystagmus was present.

Before beginning the next two tests, when asked, Mr. Short denied having any pain or injuries that would prohibit or interfere with him walking in a straight line or balancing on one leg.

Walk and turn test: I instructed and demonstrated the proper instructional stance to Mr. Short. Mr. Short initially had his left and right feet switched. Once Mr. Short was in the proper stance, I continued with the test instructions and demonstration. As I was re-capping the test, Mr. Short began the test without being told to start. During the test, I observed Mr. Short failed to touch heel-to-toe on all steps, take ten steps down, and take nine steps back.

One leg stand test: I instructed and demonstrated the test to Mr. Short; when asked, Mr. Short stated he understood the test and had no questions. During the test, Mr. Short miscounted; no other noticeable clues were observed.

When asked, Mr. Short stated he last consumed an alcoholic beverage 45-60 minutes ago. Mr. Short stated he consumed food with his alcoholic beverages. I asked Mr. Short if he would be willing to submit to a preliminary breath test (PBT), and he refused and stated, "I've always been told not to do it." I advised Mr. Short the PBT was not admissible in court, and it would give a preliminary BAC. Mr. Short stated, "I'm going to be over; I already know I am. I'm being completely honest with you." I asked Mr. Short if he's consumed more than two drinks, and he stated, "Yeah, a few. They were crown and cokes. I know I'm probably going to be over." Mr. Short stated, "You might as well just take me back to the office." Mr. Short refused the PBT.

Mr. Short was arrested for OVI. Mr. Short was handcuffed behind his back. The handcuffs were gapchecked and double-locked. I verbally advised Mr. Short of his Miranda rights. Mr. Short acknowledged his rights and stated he understood them. A search incident to arrest was completed. I sat Mr. Short in the back of my patrol car. I re-approached the vehicle and spoke with the passengers. Due to the passengers also being impaired, they contacted a sober family member to pick them up. Since Mr. Short made statements about refusing the breath test, I contacted Sergeant D. Slanker, who approved I could read the Ohio BMV Form 2255 and offer the chemical breath test to Mr. Short roadside Dispatch contacted Springfield Police Department, and at 0146 hours, Officer Clark (unit #819) stopped and witnessed the reading of applicable sections (CDL) of the Ohio BMV Form 2255. Mr. Short refused the chemical breath test. Mr. Short was issued a citation for the following offenses: -4511.13(C)- Red light/stop bar -4511.19(A)(1)(a)- OVI- Officer observations -4301.62(B)(4)- Open container Mr. Short was provided copies of the required paperwork and given a mandatory court date of Thursday, July 25, 2024, at 11:00 a.m. in the Clark County Municipal Court. Mr. Short was released to his sister-in-law
