The Affiant, Officer Collin Matt , being first sworn, says there is probable cause to believe the defendant, Shy'Ra Turton , committed an offense based on the summary of facts below:

On Thursday 07/11/2024 at approximately 2337 hours, Officer C. Matt was dispatched to _____ in reference to a possible burglary in progress with two females and a male on scene at the time of the call.

Upon Officer arrival, all alleged suspects were no longer on scene. Officer C. Matt spoke with a witness to the incident, _____ stated he heard the sound of glass breaking appearing to be coming from _____ stated the owner of _____ is his neighbor/friend _____ stated he went to investigate the sound and observed two females to the rear of _____ inside of the privacy fence with one of the females on the roof of the residence of _____ stated he knew the female who was standing on the roof to be Ms. Susan Cline, from prior incidents at this residence. _____ stated he observed the females to flee the scene on foot southbound through the alley that is directly to the east of the residence. Another witness on scene stated there was also an unknown white male on scene wearing a grey in color tank top and blue jean shorts who also fled the scene at the same time as Ms. Cline and Ms. Turton.

_____ responded to the scene and spoke with Officers in reference to this incident. _____ stated he left for work at approximately 1615 hours on 07/11/2024 and received a phone call from _____ at approximately 2321 hours on 07/11/2024 stating his sister was attempting to break into his residence. _____ stated he has had issues with his sister and niece out at his residence before and believes his sister is using drugs.

Officers observed the latch/lock for the rear gate to the privacy fence to be broken off and the fence gate forced open. Officers also observed the second-floor rear window to be broken out and damaged by an unknown object with broken glass to be on the roof. Officers observed entry to not be possible from this window due to a large wooden object blocking the entirety of the window. _____ stated he also observed damage to the lock on the rear door to his residence and stated his side windows on the west side of his residence appeared tampered with, indicating Ms. Cline, Ms. Turton, or the unknown male

suspect had the intention of making entry into the residence. After Officers cleared from the scene, _____ called back for police services with more information. _____ stated his neighbors have cameras that may have footage of the incident but stated the neighbors were currently out of town. _____ stated while searching around his property he located a bag containing paperwork with Ms. Turton's name and information on them. _____ stated after finding this bag he is positive his sister and niece were on his property and involved in the incident.

Warrants are being requested for Ms. Susan Cline and Ms. Shy'ra Turton for Criminal Damaging and Criminal Trespass.
