by engaging in a pattern of conduct, knowingly cause another person to believe that the offender will cause physical harm to the other person or a family or household member of the other person or cause mental distress to the other person or a family or household member of the other person.

TO WIT:

The defendant has engaged in a pattern of conduct that has caused the victim to feel in fear for her safety, while also trespassing on her property, being under a protection order and caused her mental distress.

In violation of Section 2903.211(A)(1) of the Ohio Revised Code.

SPECIFICATIONS:

The affiant further finds and specifies that in committing the offense under division (A)(1), (2) or (3) of this section, the offender trespassed on the land or premises where the victim lives, is employed, or attends school, or as a result of an offense committed under division (A)(2) or (3) of this section, a third person induced by the offender's posted message trespassed on the land or premises where the victim lives, is employed, or attends school.

The affiant further finds and specifies that the offender has a history of violence toward the victim or any other person or a history of other violent acts toward the victim or any other person.

The affiant further finds and specifies that in committing the offense under division (A)(1), (2) or (3) of this section, the offender made a threat of physical harm to or against the victim, or as a result of an offense committed under division (A)(2) or (3) of this section, a third person induced by the offender's posted message made a threat of physical harm to or against the victim.



The Affiant, Sergeant Denise Jones , being first sworn, says there is probable cause to believe the defendant, Brian Adlon Dague Jr., committed an offense based on the summary of facts below:

On Wednesday July 31, 2024 I met with _____ with regards to her being stalked by Brian Dague.

On July 15, 2024 _____ went to grand jury for testimony on multiple protection order violations. While testifying in grand jury it was identified she is currently being stalked by Brian and the Grand Jury returned an indictment on that charge as well. I met with _____ on July 16, 2024 to discuss her case and introduce her to a victim's advocate. Since July 16, 2024 _____ has contacted me several times.

On July 19, 2024 she contacted me to explain someone had made a fake Facebook profile of her and that she is in a relationship with Brian Dague. _____ sent me a screen shot of the post. _____ provided she has screenshots of messages between the fake Facebook profile and a friend where Brian admits its him.

On July 21, 2024 the profile from above was back up and she contacted Facebook to have them take it down. She provided she believes it is Brian and he is using the account to contact her friends and family. He is using the account to leave emoji responses on their posts.

On July 22, 2024 at approximately 1232 hours I received screenshots from _____ of her vehicle that had been spray painted. _____ also sent me screenshots of a post from Brian Dague's Facebook page. In the post he takes ownership for spray painting his "baby mama's car." He thanks Crystal for driving him and dropping her off at her parents house and letting him run and do this. He also states, "_____ have fun getting it off bitch." This post indicates direct communication with _____, that he trespassed on the property of her residence and violated the protection order in place (22DP0685) which was personally served by Deputy Bowers on October 12, 2022. _____ reported this to the Donnesville Police Department.

On July 30, 2024 at approximately 2112 hours I received another screenshot from _____ of Brian's Facebook page. In the screenshot he talks about Crystal, who has been identified as Crystal McPhee (10-05-1984) applying for a job at Soin. In the message Brian threatens to physically assault _____, "...If you don't get back with me I'm gonna fuck you up bitch..." Brian goes on in the post to state "..._____ give me my kids bitch. Me and Crystal are coming to bust your windshield if you don't give up my kids tonight bitch." I _____ advised her daughter was able to see the post and sent the screenshot to her.


_____ is afraid Brian is going to physically hurt her or kidnap and potentially hurt the kids. She is constantly looking over her shoulder and afraid Brian will show anywhere she is. She hardly leaves the house and doesn't let the kids outside because he has sent someone to the house to try and get them

to go with them.
