



**The Affiant, Deputy D Pollock , being first sworn, says there is probable cause to believe the defendant, Connor L Nawman , committed an offense based on the summary of facts below:**

On August 13th 2024 at approximately 2102 hours, dispatch received a call in reference to shots fired in the area of \_\_\_\_\_  
The reportee advised dispatch that they heard approximately 50-60 rounds.

I arrived at the bridge at 0006 hours, and observed three vehicles at the bridge. I observed a black SUV, a tan Buick, and a white car that took off before I could make contact with them. I first made contact with the individuals in the gold Buick and advised them of the reason I was there. When speaking with the driver in the Buick, who was identified as Connor Nawman, I smelled a strong odor of Marijuana. I obtained all of the individuals information, and went to speak with the individuals in the black SUV. I advised the individuals in the black SUV of the reason I was there, and obtained there identification as well. I ran all parties through dispatch, and all parties came back clear. I advised the driver of the black SUV that they were free to leave and I had no reason to keep them there.

When Deputy Reynolds arrived, I advised him of my findings of the individuals in the gold Buick. Deputy Reynolds and I approached the Buick, and I asked all parties if there was any Hemp or THC in the vehicle, and they all advised no. I then asked if there was any marijuana in the vehicle, and Dimitria Nick, who was sitting in the middle of the backseat stated they just got done smoking a blunt. The other back seat passengers were identified as Montasia Suttle, who was sitting in the backseat behind the front passenger seat and Xavier Pettiford, who was sitting in the backseat behind the drivers side.

I advised Mr. Nawman that we would be searching the vehicle, due to the admission of marijuana being in the vehicle, admission of smoking a blunt, and all parties are under the age of 21. I asked all parties in the vehicle if we were going to find any drugs or weapons in the car, and deputies were advised no. The front seat passenger, Jayden Thompson admitted to having marijuana underneath the front passenger seat in a black bag. All parties were taken out of the vehicle individually, and patted down for officer safety. Once all parties were patted down for safety, they were advised to hangout on the guardrail. I started to search the drivers side area, and observed a tan Glock 43 underneath the driver seat oriented in a way where the barrel of the firearm was facing the left side of the vehicle and the handle sticking out towards the front of the vehicle which would be accessible to the driver of the vehicle, who was Connor Nawman. Mr. Nawman was detained at that time by Deputy Reynolds, and was placed in the back of my cruiser by Deputy Reynolds. Mr. Nawman was also Mirandarized by Deputy Reynolds. I unloaded the firearm, the magazine held 10 bullets, but there were only 8 9 mm bullets in the magazine, there was also no round in the chamber. I ran the serial number through dispatch and the firearm was not entered as stolen. I continued to search the drivers side area, and found a second firearm underneath the drivers seat. The second firearm was oriented in a way where the barrell was facing the front of the vehicle, and the slide of the gun was facing the right side of the vehicle. The second firearm was accessible to the driver side backseat passenger, who was Xavier Pettiford. At that time, all parties were detained, due to finding two firearms in the vehicle. The second firearm was a Taurus G2C which had 12 9 mm rounds in the magazine, and did not have one in the chamber. The Taurus had a partial serial number of ACH1 with the rest being scratched out. Once all parties were detained, deputies continued to search the vehicle. I located a black bag underneath the front passenger seat which had one baggie of marijuana inside. I also located one baggie of marijuana in the glovebox. There was also a bottle of tequila that was opened in the backseat of the vehicle.
