Failure To Comply With Order Or Signal Of Police Officer

Complaint By Individual:

Before me, a Notary Public for the State of Ohio, a Peace Officer authorized to administer oaths or Clerk of the Clark County Municipal Court of Springfield, Ohio came OFFICER COLLIN PETERSON who being duly sworn states that on or about August 15, 2024, one RASHAD ZACHERY In the City of Springfield, County of Clark, State of Ohio did:
operate a motor vehicle so as willfully to elude or flee a police officer after receiving a visible or audible signal from a police officer to bring the person's motor vehicle to a stop.

TO WIT:

After audible siren and lights being activated on a marked patrol vehicle the defendant did flee from Officer Peterson at a high rate of speed running several stop signs in a residential neighborhood while people were walking around in the area creating a substantial risk of physical harm.

In violation of Section 2921.331(B) of the Ohio Revised Code.
