STATEMENT OF FACTS

Your Honor,

On September 7, 2024, at approximately 0306 hours, I was in a marked patrol car and wearing the uniform of the day. I was patrolling southbound on Yellow Springs Street when I observed a silver Nissan also traveling southbound on Yellow Springs Street disregarded the stop sign on Yellow Springs at Innisfallen Avenue. The vehicle did not come to a complete stop. I initiated a traffic stop and the vehicle stopped at Southern Avenue and Plum Street.

I made a driver's side approach and made contact with the driver, who was the owner of the vehicle and later identified as Alejandro Hernandez. There were was a passenger sitting on the right front and there was a passenger sitting on the right rear seat. There was a language barrier when speaking with the driver. However, the driver had a translation App. I noticed the odor of an alcoholic beverage emitting from within the vehicle. I asked him how much he had to drinks. He said "There was a birthday in my house and I only came to bring him (referring to his passenger) back to my house. I asked the question again How much he had to drink? He stated "Three beers." I asked Mr. Hernandez to step out the vehicle so I can check his eyes to make sure he is okay. I did do a pat down for weapons with his consent.

I conducted the Horizontal Gaze Nystagmus (HGN) on Mr. Hernandez and he showed a lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to 45 degrees. I asked Mr. Hernandez if he would like to take anymore test. He stated "Yes."

Mr. Hernandez perform the Walk And Turn Test, during which he did not touch heel to toe, he started before instructions were completed, and he took the incorrect number of steps, which he took ten instead of nine. I explained the test to Mr. Hernandez, and showed him.

Mr. Hernandez also performed the One Leg Stand Test during which he swayed while balancing.

Mr. Hernandez was placed under arrest for OVI due to the clues I observed. I did a search, incident to arrest of his person, and placed him in the back of my patrol car. I transported Mr. Hernandez to the Springfield Post for a test. After we arrived at the Post, Dispatcher Webb U-6357 witnessed the reading the BMV2255. I asked Mr. Hernandez if he would like to submit to a breath test. He said "Yes. A reading of .144 BrAc.

Mr. Hernandez was charged with Failure to Stop at A Stop Sign, Ohio Revised Code 4511.43A, No OL. Ohio Revised Code 4510.12, OVI, Ohio Revised Code 4511.19A1A and 4511.19A1D.

Mr. Hernandez was released to a friend.
