The Affiant, Officer Collin Peterson, being first sworn, says there is probable cause to believe the defendant, Jerome Kendal Brandon, committed an offense based on the summary of facts below:

On September 25, 2024 at 1008hrs Officers Mackintosh were dispatched to \_\_\_\_\_ in reference to a robbery. When arriving on scene officers spoke with reporting party / witness, \_\_\_\_\_ advised she was in her office when she observed a male, later identified as Jerome Brandon, standing in front of the bar area. He then walked to the side of the bar where he had to move some bar stools to get back behind the bar. The bar stools were put there to keep people from walking back there. Once behind the bar he grabs a liquor bottle off the back shelf and puts it under his jacket. When proceeding to walk out the front doors he is approached by \_\_\_\_\_. When she attempted to stop him, she advised him that she was going to call the police. He then stated "I've got a gun" so she backed off. He then left out the front doors towards Fountain and went an unknown direction.

Ms. Dunn was able to show officers video of the incident confirming everything she had advised. Mr. Brandon was wearing a white sweatshirt with blue writing on the back and blue athletic short. He had short twists in his hair that went to approximately to eye level. He also had an approximately one-inch-long beard.


Once getting the information Officers checked the area for Mr. Brandon but were unable to locate him. Officer Peterson contacted \_\_\_\_\_ by phone and requested she send video of the incident to Sgt. Byron for detectives to view. While speaking with her she advised that one of the maintenance workers was shown the video. She advised that she recognized the male and stated he plays basketball at the YMCA on Monday evenings. Officer Peterson then contacted Sgt. Evans and requested him go to the YMCA to see if anyone there was able to identify the suspect male. One of the employees advised it appeared to be a Jerome Brandon. They have had issues with him in the past trying to get into the building with members as a guest. When looking up Mr. Brandon in records officers were able to determine from the video and the pictures in records that it was in fact him. Officers attempted to locate Mr. Brandon at his residence but did not get an answer at the door.

A warrant is being requested on Mr. Brandon for Robbery.
