

**The Affiant, Detective Matthew Raines , being first sworn, says there is probable cause to believe the defendant, Jerome Kendall Brandon , committed an offense based on the summary of facts below:**

On 10-8-24 at 0946 hours, officers were dispatched to 250 Bill Edwards Dr. (HPERC/HWA) in reference to a theft. (victim/Wittenberg staff) reported that he placed his custom red Wittenberg University backpack on a chair in the northwest area of the 1929 gym at 0917 hours. When he returned to get his bag at 0935 hours, it was gone. stated that an unknown black male (entered the gym at 0918 hours) with a black hoodie with writing on the front asked him if he could use his phone. Suspect told him the reason he wanted to use his phone was to get some guys up here to play some ball and he did not have a phone. He let the male use the phone with no issue. When the suspect used the victim's phone, the phone record showed him calling (937-450-1883) and lasted for 7 seconds, no other calls were made and the number was only called once. The victim stated he had the phone for over a minute appearing to speak with someone. The suspect then leaves the gym at 0921 back to the main lobby. A few minutes later is when he noticed his bag was missing and thought his male may have taken it when he left the gym to return to work.

Officers along with staff searched the building but were unable to locate the male. stated he had 3 pair of black ear buds, 2 black phone chargers, one kilo of Kratom powder and WesBanco new acct. papers inside the backpack with a total value of \$560.00.

After I reviewed security footage from the HWA, the following was observed. was able to identify the male that used his phone from the footage. The footage shows the suspect walking through the building and checking doors. The suspect entered the building from the main entrance at 0910 hours without being identified by the two workers at the desk. He then went into the front weight room while looking over his shoulder. He was then seen in the main hallway and walk into the Streamer at 0921 hours. Suspect is seen grabbing a secured door (digital locked) before it closed when students exited the room and enter the room.

The next footage shows him exiting the room in the main hallway with three other male students at 0925 hour. He was lagging behind and not communicating with them. Once the 3 males were at the end of the hallway, the suspect turns around and tries to open the door that he just came out of, but it was locked. He is next scene in the main lobby walking into the 1929 gym at 0929 hours.

I called the phone and it went straight to a voicemail not yet set up.

The suspect is seen throughout the building with a cell phone in his hand when he told the victim he did not have a phone

The suspect is last seen on video entering the 1929 gym up the ramp from the main lobby at 0929 hours. He walks slowly straight to where the stolen backpack was located. The suspect then grabs the backpack at 0931 hours and walks away. The suspect is walking near the north wall where the camera motion did not pick him up. The suspect then would have exited from an exterior door on the northwest corner of the gym just out of sight of the camera. The other two cameras did not pick him up anywhere else in the gym and they would have if he didn't exit out the northwest door.

I was able to identify the suspect as Jerome Kendall Brandon from photo archives from Springfield High School. The victim was shown a photo lineup and positively identified the suspect.
