



The Affiant, Deputy Rodgers , being first sworn, says there is probable cause to believe the defendant, Eric C Frank , committed an offense based on the summary of facts below:

(BWCR)

On 10/20/24, I was dispatched to _____ in reference to Eric Franks being intoxicated and disorderly cursing at family members. I arrived on scene and spoke with Eric who advised he had been drinking and having an argument with his wife, _____. He stated nothing was physical and he wanted to get a ride back to the townhouses where he has a room. Eric advised me on scene that he was violating his probation by being intoxicated and provided me with his PO name and number. She did not answer, so a voicemail will be left on her work line about today. Eric had alcohol in his possession, he smelled of a intoxicating liquor, and had physical signs of impairment such as slurred speech, difficulty balancing, and glassy eyes. In addition his verbal admission to being intoxicated.

I spoke to _____ and _____ and they advised they allowed Eric to stay the night last night because _____ had fallen down, but he does not live at the residence. They stated that he had gotten intoxicated and was being disorderly and causing issues at the residence and they wanted him to leave. _____ was going to give him a ride to the townhouses, but stated that she preferred not to because his behavior and intoxication. They stated that no physical altercation occurred or has ever occurred.

While on scene, it was determined that _____ and _____ both were listed on a Final Protection Order as the protected parties from Eric. Eric and _____ both were adamant that the CPO had been dismissed and removed from the courts. I confirmed with records that Eric had been served his copy and records had a copy on file stating it was still active. Eric was placed into custody and transported to the Clark County Jail to be booked in on his charges.

Eric was at the residence because Joanne transported him there to help with her mother.

A CCH was ran for prior convictions of Violation of a Protection order and it was negative.

He was charged with 2 counts Violation of a TPO, one for _____ and one for _____.

He will have court 10/21/24 at 10:30am in the Clark County Municipal Court.
