The Affiant, Officer MacKintosh , being first sworn, says there is probable cause to believe the defendant, Eric Ray Brooks , committed an offense based on the summary of facts below:

On 10-26-2024 Officers Perilman and I (Mackintosh) were dispatched to 2989 Derr Rd reference a theft / warrant call at 1752 hours.

Dispatch was advised by Joshua Willoughby, Eric Brooks was in the store and had concealed some items in his jacket pocket. Officers located Eric R Brooks checking out at the register. Officers approached Mr. Brooks as he began to exit the store and placed him under arrest on his warrant for theft out of Clark County CN 24CRB00185. Officers were then advised by Mr. Brooks he had some items he took from the store in his pockets. Officers located 2 packs of cheese slices (right jacket pocket), 2 packs of pepperoni (left jacket pocket) , and 1 jar of mushrooms (left cargo pant pocket) on his person. These items were documented as a value of \$25.34. The items were returned to Mr. Willoughby. Mr. Brooks was charged with 1 Count of Theft.

Mr. Willoughby then provided two DVD's of previous incidents. The first DVD was CN24-37536. This was forwarded to Det. Devore previously and a trespass letter was completed and had yet to be served. Mr. Brooks was advised of the trespass letter and was served.

The second DVD was an undocumented theft from 10-09-2024 around 1300 hours. I was able to view the footage and verify the suspect as Eric R Brooks. Mr. Brooks is seen on video surveillance placing multiple items in his pockets as he was pushing a shopping cart around the store. Mr. Brooks is then seen leaving the store at 1313 hours, passing all points of sale. Another case number was created for this incident CN 24-40793. Eric R Brooks was charged with 1 Count of Theft.

Security video from CN 24-37536 was placed into property under receipt # 40753, security video from CN 24-40793 was placed into property receipt # 40754.

Eric R Brooks was placed in the Clark County Jail on his outstanding warrant CN 24crb00185, 1 Count of Theft - CN 24-40784, 1 Count of Theft - CN 24-40793
