The Affiant, Officer Oneil, being first sworn, says there is probable cause to believe the defendant, Harold Earnest Denney Jr, committed an offense based on the summary of facts below:

On 10/25/2024 emergency tones were dropped by dispatch for a burglary in progress.

advised that Harold Denney Jr. had just kicked in her door and was in her residence assaulting her in front of her children. I, Officer Walter was pulling up on scene as the tones were dropped, due to the call pending for several minutes.

Upon arrival I observed Harold Denney Jr. walking on the rear-East side of the residence with a black sweatshirt and khaki pants on. Harold turned and made eye contact with me and took off running, as I instructed him to stop. Harold continued to run north, as he scaled a fence and ran out of my sight.

After a brief foot pursuit I returned to the residence to speak with . regarding tonight's incident . advised that around 2300 hours she heard banging at her rear door and what sounded like someone trying to open it. Due to recent attempted break-ins by Harold, . had barricaded her rear door for safety, but did not have anything to put in front of the front door. Shortly after the banging stopped at the rear door, her front door was kicked in by Harold. Harold entered the residence through the damaged front door and began striking . on the right side of her body, including her legs, arms, chest and head. Harold struck . in the face twice with an open palm. This assault caused visible injury to . right arm and the right side of her face.

was able to alert her neighbor Amanda Laughrey, by flipping the front porch lights on and off. Amanda also called for emergency services after seeing . distress signal. Amanda did observe Harold inside the residence.

advised that she and Harold ended their relationship nearly a week and one half ago, after Harold sold her engagement ring for drugs. Since terminating the relationship, Harold removed all his clothing and personal items out of the residence, located at 918 W. Pleasant St. . and Harold had previously dated for a year and do not have any mutual children together.

Officer checked the area but were unable to locate Harold.

I took photos of the scene and . injuries.

A warrant is being requested in the name of Harold Denney Jr. for one count of burglary and one count of assault.

On 10/26/2024 at approximately 1907 hours, Officers O'Neil and Hopewell were dispatched to 905 W Pleasant St reference to the above person here. Harold Ernest Denney Jr. was located when Officers arrived on scene. Mr. Denney Jr. was arrested without incident. Mr. Denney Jr was arrested on warrants as well as the above charges.


