Complaint By Individual:

Before me, a Notary Public for the State of Ohio, a Peace Officer authorized to administer oaths or Clerk of the Clark County Municipal Court of Springfield, Ohio came DEPUTY ANTHONY REYNOLDS who being duly sworn states that on or about October 26, 2024, one AUSTIN WILE In the Township of Bethel, County of Clark, State of Ohio did: without privilege to do so and with purpose to prevent, obstruct, or delay the performance by a public official of any authorized act within the public official's official capacity, do any act that hampers or impedes a public official in the performance of the public official's lawful duties.

TO WIT:

Defendant, Austin Wile, Did, without privilege to do so and with purpose to prevent apprehension by a Clark County Sheriff's Deputy, flee from a lawful stop stemming from a shots fired call, which resulted in a vehicle pursuit involving speeds in excess of 100mph and further caused a motor vehicle accident.


