Statement of Facts

Your Honor,

On Wednesday, November 20, 2024 at approximately 0904 I was patrolling southbound on Clifton Avenue, near John Street in the City of Springfield. I was patrolling in a fully marked patrol car wearing the uniform of the day when I observed a white Lexus turning northbound on Clifton Avenue from John Street with dark window tint on the front driver and passenger windows. I made U-turn to conduct a traffic stop on the vehicle. The driver, later identified as Jon Bussard, turned onto Wilson Avenue before coming to a stop. I approached the vehicle on the passenger side and advised Bussard the reasoning for the stop, and the window tint was checked at 18%. I asked Bussard for his driver's license and he stated he did not have one. Due to Bussard having no identification on him. I had him exit his vehicle so I could identify him on my computer. Bussard was located within L.E.A.D.S. and was found to have an active warrant out of Clark County and did not possess a valid license. A towing service was called to the scene to retrieve the vehicle. An administrative inventory was conducted for the safe keeping of the vehicle and its property within it. During the inventory two baggies of a crystal rock like substance, meth, were located within a blue bookbag that was on the passenger floorboard as well as two glass smoking pipes with residue. The pipes and meth were seized as evidence and Bussard was arrested for his warrant and the on-view charges. Bussard was issued a citation for Window Tint restrictions, driving under suspension and failure to reinstate. Bussard was issued a criminal citation for possession of a controlled substance and drug paraphernalia and incarcerated into the Clark County Jail for the active warrant and the charges. The meth and glass smoking pipes were sent to the OSP Crime Lab.
