The Affiant, Officer G Mefford , being first sworn, says there is probable cause to believe the defendant, Lisa Dawn Rankin , committed an offense based on the summary of facts below:

On 11/23/24 at 2041 hours, Officers C Johnson and G Mefford were dispatched to _____ reference
a female breaking into an apartment and throwing items from a balcony into the yard.

Officers arrived on scene and were greeted by the caller, _____ who advised the suspect, Lisa Rankin,
was the one Officers walking back inside to _____. Ms. Rankin stepped out and was placed in custody
for outstanding warrants for theft. Officer Mefford was escorted to the upstairs unit by _____.

_____ advised that she is the only person permitted to be inside the resident, as the landlord, _____, made
her a key. Around 2000 hours, _____ observed Ms. Rankin upstairs throwing items off the balcony of the
upstairs apartment. The apartment in question had residents that just moved out the day prior and were currently
on their way to Louisiana. The residents left some property behind and advised that _____ was allowed to go
through and take what she needed, and the rest could be discarded.

_____ advised that on top of the property strewn about the front yard, she had taken some items inside the
residence at _____ including an AC unit and food. _____ witnesses her upstairs with the balcony door
open discarding items, and believes she may have made entry through there. Officer Mefford spoke with _____
the landlord, who confirmed Ms. Rankin did not have permission to be taking items, let alone be inside the
upstairs unit.

While being taken to the jail, Ms. Rankin made unprompted statements asking how she could be charged with
B&E because she was only inside the residence for a second. Car audio from Car #26 also captured the
statements.

Lisa Rankin is being charged with one count of Breaking and Entering, and was also served on her warrant for
Failure to Appear on Theft (23CRB02348). Ms. Rankin was transported to the Clark County Jail where she was
booked in.

DNA is on file for Ms. Rankin.
