The Affiant, Deputy Rodgers , being first sworn, says there is probable cause to believe the defendant, Calvin Oshay Mathews , committed an offense based on the summary of facts below:

(BWCR)

On 11/23/24, I was patrolling Moorefield Twp. when I _____ advised over the radio that his cruiser was struck by a stolen vehicle he was attempting to locate and was fleeing the scene. I was in the immediate area and located the vehicle traveling South on Middle Urbana Rd. I began to pursue the vehicle as the primary deputy as the vehicle made a turn on to 334 traveling West. The vehicle was being pursued due to being a entered stolen vehicle and assault on a Deputy with a vehicle. The road conditions were wet due to scattered showers. The vehicle was called out and observed to be driving without any lights on. The vehicle continued West to Derr Rd. which had an active red light and the suspect vehicle slowed down as if to yield to the light. The light turned green and they continued to attempt to elude law enforcement. The vehicle continued to travelling West at speeds approximately 90 mph. The suspect had at some point activated their headlights and taillights. The suspect continued West on SR 334 at a high rate of speed past highway 68 and 72. The vehicle continued down River Rd slowing down for curves. The vehicle then left the roadway and began traveling Southwest through a open field after crossing the bridge at Moore Run river. The vehicle reach the tree-line next to the Mad River and I observed two males wearing a blue and Red/pink tops exit the vehicle and flee into the woods. As I was getting out of my cruiser a female exited the passenger door and turned herself into deputies. The female was identified as Ashley Tillman and she was detained and mirandized.

Through a massive effort from multiple agencies, the driver was located in the fields and taken into custody. The driver was detained by Sgt. Slanker with OSP. The Sgt. mirandized the suspect and identified the suspect as Calvin Mathews. Calvin identified himself as the driver. Sgt. Slanker stated that Calvin stated that he was in the area looking for a car to steal and observed a deputy park in front of him. Calvin stated that he knew the car he was in was stolen and attempted to flee the area. In attempt to flee, he knowingly struck a deputies cruiser and another parked car. This crashed caused physical pain to the deputies neck and head.

The passenger was believed to be a Caiden Neu and was unable to be located.

A CCH was ran on Calvin. A DNA sample was collect from Calvin at the Jail to be turned into BCI.

Calvin was transported to the and booked in on Felonious Assault, Receiving Stolen Property, and Failure to Comply.
