The Affiant, Ofc. River Oates , being first sworn, says there is probable cause to believe the defendant, Melissa Ann Thacker , committed an offense based on the summary of facts below:

On 11/27/24 at 1236 hrs, 421E (Officer Oates and Officer Peterson) were dispatched to the intersection of S. Western Ave and W. Main St. for a Motor Vehicle Accident.

_____, was driving 2023 Nissan Pathfinder Westbound on W. Main St. towards S. Western Ave, as she was approaching the intersection, she had a green light, so she proceeded through the intersection. At that time, Melissa Thacker, driving her 2010 Hyundai Accent, Northbound on S. Western Ave. towards W. Main St. As she was approaching W. Main St. Ms. Thacker had her two juvenile sons who were in the rear seats. She did not observe the red light, and failed to stop. Ms. Thacker proceeded through the intersection, and struck _____ on the driver side rear passenger door. The impact caused _____ to flip her car on its passenger side. Ms. Thacker's vehicle stopped next to _____ vehicle. After arriving on scene, Officers noted two children walking around the scene, but were unable to determine if they were involved in the accident. The two children were unable to communicate with Officers. Ms. Thacker was trapped in her vehicle and was extricated by non mechanical means, and was transported to SRMC by Springfield Fire Rescue Division. It was found that the children were in Ms. Thacker's vehicle, and they had been in the vehicle at the time of the crash, and were able to get out of the vehicle safely through the passenger rear door, and were not wearing seat belts at the time of the crash. Child Victim 1 and Child Victim 2 are both children of Ms. Thacker.

After arriving to the hospital, Officers and Nurses attempted to talk with Ms. Thacker, but found that she was non cooperative. Nursing staff were frustrated with Ms. Thacker because she was repeating herself, stating that her kids were not in the car at the time of the accident, when they were. Officer's noted that Ms. Thacker's mannerisms, along with bloodshot eyes, slurred speech, and the odor of alcoholic beverage on her breath. When asked, Ms. Thacker stated that she had approximately 5 to 6 shots of tequila a few hours prior to the accident. Ms. Thacker was then read and shown BMV 2255, and was offered a blood test, to which she accepted. At 1422 hrs, _____ drew blood from Ms. Thacker. The blood kit that was used did not expire until 2026. Both blood tubes were observed with white powder in both of them. The initial blood draw was completed, but was not sufficient due to the use of a alcohol swab to clean draw site. A second blood kit was used, which did not expire until 2026. Both tubes were observed with white powder, and an iodine swab was used to clean the draw site. While dealing with Ms. Thacker, it was found that both of the children sustained minor injuries as a result of the collision.

Due to her injuries she sustained from the accident, Ms. Thacker was transported to Miami Valley Hospital. Officer Young took photos of the accident. Warrants are being requested for two counts of Endangering Children, one count of Operating a Motor Vehicle While Intoxicated, one count of Failure to Wear Safety Restraint, and one count of Obedience to Traffic Control Device were filed.

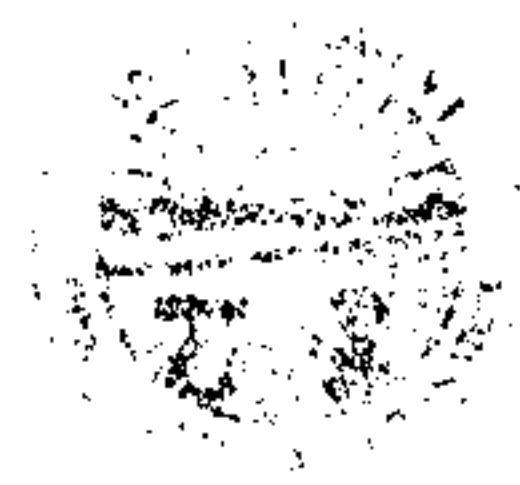
