





The Affiant, Officer K. Kitchen , being first sworn, says there is probable cause to believe the defendant, Theodore Thomas Ruhe , committed an offense based on the summary of facts below:

On 12-31-2024 at approximately 0335hrs Officers N. Crone and K. Kitchen were dispatched again to in reference to Theodore Ruhe continuing to cause issues and breaking out one of the windows to the residence. Upon arrival Officers located Mr. Ruhe across the street at Gateway Gardens Apartments at 501 S. Limestone St. Officers detained Mr. Ruhe and then went to the scene to speak with the caller and witnesses. Officers had been out here due to altercations between Mr. Ruhe and and residents of on several other occasions (24-50034 and 24-50050). In the first incident Mr. Ruhe had to be advised by Officers of a disorderly warning due to him actively threatening and wanting to fight and others at .

For this incident when Officers made contact with I and her fiance, Ernest Hitch, they advised that they were inside the residence when they heard glass breaking. Mr. Hitch advised that when he came outside he found a window broken and Mr. Ruhe was standing across the street yelling at him. Mr. Hitch advised that Mr. Ruhe was yelling at him and admitted to breaking out the window, while calling him vulgar names.

While still on scene Officers also made contact with a who advised that around 0130hrs she was outside of the residence. I advised that Officers had just finished speaking with Mr. Ruhe for the second time and left the scene. I advised that after Officers left the scene Mr. Ruhe began yelling at her and making threats to kill her and her family. Ms. also advised that Mr. Ruhe also made threats that he was going to have his mom come assault her. Officers filed charges for Menacing in this incident (24-50060).

Officers transported Mr. Ruhe to headquarters to complete the appropriate paperwork. Once in the workroom Mr. Ruhe began making statements that when he gets out of jail he was going to go back and assault Mr. Hitch, _____ for making false statements against him. Mr. Ruhe while sitting in the workroom began making statements that he was going to break the handcuffs on him and was going to break out of Police Headquarters when he gets his hands free. Mr. Ruhe then tried twisting and breaking the chain on the handcuffs and was subsequently placed in a holding cell while Officers worked on paperwork. Once in the cell Mr. Ruhe began kicking and hitting the doors inside the cell.

Theodore Ruhe was charged with Criminal Damaging in this incident but was also charged with Menacing (24-50060). Mr. Ruhe was placed in Clark County Jail until his court date of 1-2-2025 at 1030am.


