





The Affiant, Officer T Young , being first sworn, says there is probable cause to believe the defendant, Candice Crouch , committed an offense based on the summary of facts below:

On 1-5-25 at approximately 1211 hours, I, Officer Young, was dispatched to a female threatening a male with a gun. in reference to

Upon arrival, I made contact with \_\_\_\_\_ who advised at around 1205 hours, his girlfriend Candice Crouch (defendant) brandished a firearm at him. \_\_\_\_\_ said he has been having issues with Ms. Crouch all day. said him and Ms. Crouch got into an argument inside of her apartment at \_\_\_\_\_ at around 1100 hours. He advised Ms. Crouch got angry at him and grabbed his car keys from him then ran out the front door. He said she got into his gray 2007 Dodge Ram bearing \_\_\_\_\_ and drove off with it. He said she took a firearm with her and was possibly high on drugs. Mr. Perkins advised she didn't tell him where she was going. While speaking with ....

\_\_\_\_\_ , I had him call Ms. Crouch on her cell phone and she stated she would bring the vehicle back to him but it would be a while.

\_\_\_\_\_ said she returned his truck back to him at around 1200 hours, where he met her in the parking lot. He said Ms. Crouch gave him back his truck keys, but she still had another set of keys that were attached to his keyring. He said his other car key was on the keyring she stole from him, containing keys to a 2011 Chrysler 200S \_\_\_\_\_ also advised there were other keys on the keyring but he couldn't remember what they were for. He stated she refused to give them back to him. \_\_\_\_\_ advised they walked back up to her apartment where she attempted to shut the door in his face.

\_\_\_\_\_ said she lifted up her shirt while facing him behind the front door, and exposed a chrome plated handgun that was tucked behind her front waistband. He said Ms. Crouch stated to him, "I'll shoot you." after exposing the firearm. I Perkins said he went back downstairs afterwards and called the police.

\_\_\_\_\_ advised he has been staying with his girlfriend for a while, and had his clothes and belongings inside of the apartment.

Myself and Officer McCutcheon attempted to knock on her apartment door but did not get an answer. \_\_\_\_\_ told me that she texted him saying she was walking back to Dayton. I checked the surrounding areas and was unable to locate her. A warrant is being submitted on Candice Crouch for Domestic Violence, Aggravated Menacing, and Theft.
