



The Affiant, Deputy Anthony Reynolds , being first sworn, says there is probable cause to believe the defendant, Hunter Michael Lee Powell , committed an offense based on the summary of facts below:

BWCR / ICCR

On January 19th, 2025, Deputies were dispatched to _____ In the Township of Bethel, County of Clark, State of Ohio, In reference to a threats call. It was advised that the original RP, _____, was calling to report continued harassment from her ex-boyfriend, Hunter Powell. While in route to the Sycamore address, Dispatch received a second call from a Michael Powell, father of Hunter Powell, stating that Hunter had left their residence in Miami County, and that Hunter was in route to Medway to kill someone by the name of _____. This was later found to be _____ the brother of _____. Continuing towards the address, It was learned that Hunter had made it into Clark County, before Michael had stopped Hunter, and told him to turn back to their address in Miami County. Deputies requested Huber Heights PD to perform a welfare check at the address of 9748 S. Palmer Road.

Once on scene at _____ Deputies met with Jenna Brewer and _____. Speaking with them. It was learned that _____ and Hunter had broken up on Monday, January 13th, 2025. Since the break up, _____ advised that Hunter had been calling and texting her every day, harassing her. _____ advised that she was making attempts to be civil and for Hunter to gather his belongings out of their residence at 12 Maple Dr, but that on January 17th, 2025, Hunter had gone to the address and kicked the door in. _____ call for assistance that day, however due to established residency, _____ was advised that this incident was a civil issue. Over the course of the days since then, _____ stated that Hunter has called or text her well over 100x times, over multiple days. _____ advised that she had told Hunter to stop contacting her, and went as far as blocking Hunter via phone and social media, but that she unblocked him to attempt civil communications reference property. _____ continued by stating that Hunter would call her on Facebook messenger, multiple times back to back, making threats, to which her brother _____ got involved and also told Hunter to stop contacting her. This ultimately led to Hunter beginning to make threats to both _____.

During tonight's incident, It was learned that Hunter had sent messages to _____ via text that included a direct threat to _____ life. In these messages, Hunter states " _____ got one coming". " Your fucking dead to me after ts", "So is that nigga and he really gon be dead" These messages were sent just prior to the call for service from _____ about the continued harassment, and the second call that Hunter had left his address in Miami County, stating that he was on his way to kill _____.

Due to the continued harassment via phone, text and social media, and the actions of Hunter attempting to come to the residences of both _____ along with the threat to _____ life, Hunter Powell was taken into custody by Huber Heights PD, where he was transported into Clark County, where custody was transferred. Hunter was then transported to the Clark County Jail.

Prior to transport, Hunter was read miranda, and make statements that he had called and texted _____ a bunch of times, and further that his anger got the best of him and he had made threats to James.

Hunter Powell is presently charged with telecommunications Harassment, Menacing by Stalking and Aggravated Menacing. Hunters arraignment is scheduled for January 21st, 2025, at 1030am in the Clark County Municipal

Courthouse.
