of neuropathy. The subject later known as Edward A. Balliet was seen and discharged by a doctor. After being discharged Balliet was refusing to leave the hospital. Police and security personnel were called back to tell Balliet that he was discharged and that he needed to leave the property. We were able to get Balliet to leave the emergency dept. through the EMS doors. Balliet would then began to yell and curse at us. Balliet was told to have a good night and that he needed to leave the property. Balliet has been kicked out of all the homeless shelters here in the city. Balliet would make his way back to the front entrance to the emergency dept. and try to come back into the building. I advised Balliet several times he needed to leave the property and he refused. Balliet made his way into the vestibule area of the entrance and took a position with his back against the glass. I again told Balliet he needed to leave the property or he would have criminal trespass charges filed on him. Balliet stated that he did not care if he was arrested. Balliet stated multiple times to arrest him but being the only police officer on duty I could not arrest him and leave the hospital without a police officer. Springfield police were called and a transport was requested but at first was denied. A second call was placed for a transport and was again denied. Balliet then was attempting to spit on a security guard on duty and also tried knocking over the metal detector. I called again to speak to Lt. Holt and asked if we got the charges filed could they do a transport and we could drop the charges off at the court house in the morning. Lt. Holt agreed and also stated that the jail sargent would keep him when he was brought in.
