

The Affiant, Off McCutcheon , being first sworn, says there is probable cause to believe the defendant, Cassandra W Watts , committed an offense based on the summary of facts below:

On this date Officers were dispatched to the Townhouse Motor Lodge at 2850 E. Main St room 28 on a report of a motor vehicle theft. Upon arrival Officers spoke with the victim,

stated that several days before she had allowed her daughter, Suspect Cassandra Watts, to use her listed vehicle to make "insta cart" deliveries. Her daughter then refused to return the vehicle. On this date stated that her daughter drove the car back to this location to return her mothers phone. Ms. Watts refused to give up the car though. stated that she didn't want her daughter to take her vehicle again so she stabbed a hole in one of her tires. Ms. Watts became irate and grabbed by the throat while threatening to kill her. After a brief argument Ms. Watts got back into the vehicle and went to stand in front of the vehicle. Ms. Watts then attempted to strike with the car as she fled the scene.

had no visible injuries from the attack but did fill out a PC statement.

did not have any visible injuries but was clearly shaken. She declined any medical attention. Officer checked the area but were unable to locate the vehicle. Warrants are being requested for Cassandra Watts for one count each of Robbery, Strangulation, DVF and Assault. Ms. Cassandra Watts. Her DNA is already on file.
