The Affiant, Detective Joshua Emory, being first sworn, says there is probable cause to believe the defendant, Jovan Darnell Harris, committed an offense based on the summary of facts below:

Initial Narrative:

FOR WARRANT ONLY

On December 31, 2024 at approximately 0111 hours, a tone was dropped for Speedway, 405 South Burnett Road in reference to a robbery. Upon arrival, Officers met with the victim, Lori Dean about items being stolen from her.

Ms. Dean advised that she was using the ATM to get money out for the rent that was due. While using the ATM there was a male behind her that seemed to be waiting to also use the ATM. The male seemed to be talking with a female, but Ms. Dean did not know if the two were together. After getting her money out of the ATM, Ms. Dean placed it inside her wallet that was inside her walker/chair she uses for mobility assistance. Ms. Dean then finishes up at the ATM screen when she sees the male by her chair and then lifting it to get the money. The male takes her wallet, with her license, social security card, food stamp card and money she had just gotten out of the ATM. The male then runs out of the store going north and then west bound before the camera loses sight of him.

The male was observed to be an African American dressed in a black zip up jacket and black nikes sweatpants. The male also had on tan duck boots with a black leather top. The male appears to be 507-509 and slim build. The female he was talking with was a caucasian female wearing a black and gray two toned winter jacket with a black and white scarf and hat set. The female appears to be 506 to 508 and is heavy set.

No personal information is available for the suspect at this time. Video of the incident was taken on a department issued camera. A note was left for the store owner to burn the video to a disc.

Detective J. Emory:

I collected the Video from Speedway regarding this incident. Upon review of the footage I was able to identify the male in this video as Jovan Harris. In the video he comes into the store with a female and she gets some belonging and pays for them. He is seen talking to her and it appears she holds the door open for him while he grabs Mr. Dean's wallet and flees the store. I was able to locate Springfield PD case number 24-43992. In this incident Shayla Parsley is with Mr. Harris she states she is living with him in SPD incident number 23-04383. Upon looking at her Facebook and OHLEG photos it appears she is the female inside the store with Mr. Harris.

Mr. Harris was served a trespass letter for this Speedway location on 5/19/23 by Off. Lykins (23-17337).

I am requesting warrants on Jovan Harris for one count of theft and one count of Criminal Trespass at this time.


