Complaint By Individual:

Before me, a Notary Public for the State of Ohio, a Peace Officer authorized to administer oaths or Clerk of the Clark County Municipal Court of Springfield, Ohio came Kadawni Scott, who being duly sworn states that on or about December 11, 2024, one Brian Sparks in the City of Springfield, County Clark, State of Ohio did:

Purposely or knowingly, and when purpose or knowledge is sufficient culpability for the commission of an offense, shall engage in conduct that, if successful, would constitute or result in the offense;

With intent to harass, annoy, threaten, or alarm a law enforcement officer, shall cause or attempt to cause the law enforcement officer to come into contact with blood, semen, urine, feces, or another bodily substance by throwing the bodily substance at the law enforcement officer, by expelling the bodily substance upon the law enforcement officer, or in any other manner.

TO WIT:

The Defendant attempted to spit on the deputies.

The Affiant, Deputy Schutte, being first sworn, says there is probable cause to believe the defendant, an Scott Sparks, committed an offense based on the summary of facts below:

Your Honor,

On December 11, 2024, Deputy Whittemore and I were dispatched to _____ for a Disorderly call. When we arrived on scene there was an white male walking towards us from the driveway. The gentleman stated he is _____. I asked _____ what happened. _____ stated his step son Brian Sparks punched him while he was asleep. Then I _____ defended himself escaped from being assaulted by Mr. Sparks by getting out from the back to the back porch and then Mr. Sparks started tearing everything in the house. I started to enter the home at this time till I heard a large crashing noise from the back of the house. Deputy Whittemore and I started walking towards the back of the house then _____ yelled towards our direction stating he is in the house.

I entered the home seeing I _____ the _____ of Brian Sparks. speaking to someone. I heard an unknown voice who was later identified as Mr. Brian Sparks talking to _____. I heard a spitting noise coming from Mr. Sparks then I heard him state I will spit on you to. I walked around the corner towards Mr. Sparks where I heard him attempt to spit again. I placed Mr. Sparks against the wall, I made him sit on the ground then I told Mr. Sparks to get on his stomach to be placed into handcuffs. Mr. Sparks was actively resisting me till Deputy Whittemore brought his taser out of the holster and was warned Mr. Sparks if he actively resists anymore he will be tased. Mr. Sparks complied and was placed into handcuffs without issue.

I escorted Mr. Sparks to the cruiser and had him secured in the cruiser. Deputy Whittemore conducted interviews with _____ and I _____ who stated she had an argument with Mr. Sparks trying to calm him down. _____ stated he was drinking throughout the night blaring his music throughout the night. Mr. Leatherman stated to Deputy Whittemore he was sleeping when Mr. Sparks came into the bedroom pull the bed cover off and started assaulting him. _____ defended himself then got out of the house from the back door to get away from Mr. Sparks. Mr. _____ did have a small amount of blood on the left side of his head, believed to be from being struck by Mr. Sparks.

At this time I went back to my cruiser and spoke to Mr. Sparks informing him he was under arrest of Domestic Violence and Assault. Mr. Sparks did not care and spit towards my direction hitting my cruiser interior door. I informed Mr. Sparks there was no cause for him to spit at me and Mr. Sparks did not care what I had to say to him. Deputy Whittemore closed the cruiser door. I am adding an additional charge to Mr. Sparks of Harassment of Bodily Substance.

A CCH was ran on Mr. Sparks, _____ and _____ refused to sign witness statements and answer any domestic victim information. Deputy Whittemore asked _____ if he would like to speak to an advocate at which time he refused.
