

The Affiant, Deputy Stillings , being first sworn, says there is probable cause to believe the defendant, Kristy Tatman , committed an offense based on the summary of facts below:

On 4/3/25, I took a phone report from a _____ in reference to threats she is receiving from a Kristy Tatman. _____ did send the screen shots to dispatch. In reviewing the message it shows they are coming from a Facebook account of Kristy Tatman. One message states "I fully intend to beat the shit out of you. I will pull out your hair, kick you so many times, ideally in the mouth." She proceeds to call _____ fat and sloppy. Kristy states "enjoy what happens next." Another message states she will be at Morris Bean today. This is where the reportee _____ works. She also states she will be waiting at her house and list her address of _____. One message threatens to break into _____ house in the middle of the night. One reply from Kristy states she is aware she will go to jail but it will be totally worth it. In speaking with the reportee _____, she states she is friends with Kristy husband because they used to work together. _____ says Kristy apparently got on her husbands Facebook and saw they were messaging each other. This is when she started messaging _____ on Facebook and texting her. I was able to locate a possible address for Kristy. Myself and Deputy Likens went to 2999 S Buena Vista Road to make contact with Kristy to get her side of the story and to confirm she was the one sending the messages. We were able to make contact with her at this address. As she answered the door, she said she knew why were there. I asked her to tell us about what happened. She did admit to sending all the messages to _____. Kristy states she has been married to her husband for many years and she found messages from _____ to her husband. Kristy mentioned on said "love you" something about "kisses." Kristy said she messaged out of anger and did not mean any of it and would never follow through with any of what she said. I explained to her understood it but that she can't do that. I told her since we established her as the suspect, I did read her Miranda Rights. I called _____ back to inform her we did make contact with Kristy. I asked her if she wanted charges if we had enough to do some or would be going the protection order route. _____ stated if she was in Kristy shoes she would never make the threats that Kristy did and that she wanted her charged. I returned back to let Kristy know that the victim did want her charged. I informed Kristy she was being charged with telecommunications harassment. In the (A) (6) section of 2917.21 it covers the menacing over telecommunication devices. She was served her copy of the affidavit and ordered into Clark County Municipal on 4/4/25 at 10:30 a.m. I uploaded 4 photos of screen shots via Axon Capture.
