**The Affiant, Officer Amanda Rosales , being first sworn, says there is probable cause to believe the defendant, Destynie R Day , committed an offense based on the summary of facts below:**

On 04/13/2025 at approximately 0125 hours Officers Bartlam and Rosales (512L) were dispatched to due to reports of a domestic assault.

Upon arrival Officers spoke with the victim and reporting party stated that he was assaulted by his ex-girlfriend, Destynie Day, whom he has a child with. stated that he left his residence on 04/12/2025 at approximately 1230 hours. stated he returned to his residence at approximately 0118 hours on 04/13/2025. stated that upon returning to his residence, he noticed that his bedroom had been ransacked and items had been thrown about. stated that he did not notice any items missing from his house or anything damaged.

stated that he then noticed his car had also been gone through. stated that he noticed that inside his car he was missing a Bluetooth piece and his cousin's garage key. stated that he received a phone call that night from his Cousin, Officer Bartlam called 1800 hours where she stated she had broken into who claimed Ms. Day admitted to taking the key from to confirm this. stated that he received a call from Ms. Day at approximately car and taken the garage key.

stated that he and Ms. Day had previously been in a relationship. stated the relationship ended three weeks to a month ago. stated Ms. Day has never lived at the residence. stated that Ms. Day knows the passcode to the residence due to their prior relationship. stated that Ms. Day has never been over to the residence unannounced before and has no expectation that she would be able to come and go as she pleases. showed text messages to officers on scene where he told Ms. Day to stop attempting to contact him and not to touch his possessions.

stated he was at his residence on at approximately 0118 hours when Ms. Day showed up to confront him. stated that he went outside the residence to meet her as she walked inside the fenced yard. stated Ms. Day immediately walked up to him and began striking him. stated he was struck about the chest, shoulders, and torso several times with closed fists. stated Ms. Day attempted to strike him approximately ten times.

stated that Ms. Day then ran around him and forced her way fully into the residence through the closed door. stated he then ran up to her and attempted to remove her from the residence. stated Ms. Day was holding onto the doorframe to prevent from removing her. stated that during this struggle, Ms. Day bit him on the right side of his chest. then stated he was able to pull Ms. Day away and out of his residence. Ms. Day then left the scene. Officers arrived shortly thereafter.

Officers on scene were able to observed fresh irritated red marks about chest, shoulders and torso. Officers were also able to observe a fresh, irritated bite mark that broke the skin on the right side of chest.
