

The Affiant, Officer Luke Bartlam , being first sworn, says there is probable cause to believe the defendant, Destynie R Day , committed an offense based on the summary of facts below:

On 04/13/2025 at approximately 0125 hours Officers Bartlam and Rosales (512L) were dispatched to _____ due to reports of a domestic assault.

Upon arrival Officers spoke with the victim and reporting party _____ stated that he was assaulted by his ex-girlfriend, Destynie Day, whom he has a child with.

_____ stated that he and Ms. Day had previously been in a relationship. _____ stated the relationship ended three weeks to a month ago. _____ stated Ms. Day has never lived at the residence. _____ stated that Ms. Day knows the pass code to the residence due to their prior relationship. _____ stated that Ms. Day has never been over to the residence unannounced before and has no expectation that she would be able to come and go as she pleases. _____ showed text messages to officers on scene where he told Ms. Day to stop attempting to contact him and not to touch his possessions.

_____ stated he was at his residence on _____ at approximately 0118 hours on 04/13/2025 when Ms. Day showed up to confront him. _____ stated that he went outside the residence to meet her as she walked inside the fenced yard. _____ stated Ms. Day immediately walked up to him and began striking him. _____ stated he was struck about the chest, shoulders, and torso several times with closed fists. _____ stated Ms. Day attempted to strike him approximately ten times.

_____ stated that Ms. Day then ran around him and forced her way fully into the residence through the closed door. _____ stated he then ran up to her and attempted to remove her from the residence. _____ stated Ms. Day was holding onto the doorframe to prevent _____ from removing her. _____ stated that during this struggle, Ms. Day bit him on the right side of his chest _____ then stated he was able to pull Ms. Day away and out of his residence. Ms. Day then left the scene. Officers arrived shortly thereafter.

Officers on scene were able to observed fresh irritated red marks about _____ chest, shoulders and torso. Officers were also able to observe a fresh, irritated bite mark that broke the skin on the right side of _____ chest.

Officer Bartlam took photographs of the scene and _____ injuries.
