The Affiant, Detective Jolene Irons, being first sworn, says there is probable cause to believe the defendant, Steven Louis Teets, committed an offense based on the summary of facts below:

Your Honor,

On 4-17-24 the Clark County Sheriff's Office took a sexual assault complaint involving a female juvenile victim with the alleged perpetrator being the household family member.

Clark County received online social media texts involving the female juvenile victim. She was talking about the most recent incident being earlier in the day on Thursday 4-17-24 with the alleged perpetrator choking her and not being able to breath. She talked about him forcing himself in her.


The female juvenile victim was taken to Dayton Children's Hospital and completed a forensic interview with Clark County CPS and completed a sexual assault kit. She made disclosures about the perpetrator frequently sexually assaulting her for at least the past two years.


On 4-21-25, the alleged perpetrator was taken into custody by Clark County Deputies. He refused to speak to this detective and requested a lawyer. He was booked into the Clark County Jail for rape, strangulation, and domestic violence.
