The Affiant, Officer A. Johnson, being first sworn, says there is probable cause to believe the defendant, Christopher Lee Stewart, committed an offense based on the summary of facts below:

On 04/27/2025, dispatch dropped emergency tones for a person on a dirt bike firing a gun in the area of _____

Upon arrival, Officers observed multiple 9mm brass casings in the roadway near _____ and ensured no one was injured. Officers then went over to the residence of _____ and spoke to the reporting party, _____ stated that a male by the name Christopher Stewart just drove by north bound on a green and black dirt bike and fired multiple rounds in the air. He stated before this incident Mr. Stewart was driving his dirt bike up and down _____ in front of his residence. He stated he attempted to speak with Mr. Stewart to advise him to stop riding his dirt bike in the street. _____ advised that Mr. Stewart stated "I got something for you". Due to there being multiple people outside _____ was not positive if Mr. Stewart was speaking to him or anyone else outside. _____ then went inside his residence to call the police. While standing just inside the doorway of his home _____ stated he heard multiple gun shots outside his house.

Officers then spoke with another witness, _____ She lives at _____ which is directly next to _____ She advised she was standing in her doorway looking out into the roadway. She stated she observed a male named "Chris" on a dirt bike firing multiple shots into the air heading north bound on Clifton Ave. She advised she did not know his last name but it is believed to be Christopher Stewart.

Officer Ray and Officer Cochran collected 5 9mm shell casings from the roadway in front of _____ They were submitted to property under property receipt # 36435.
