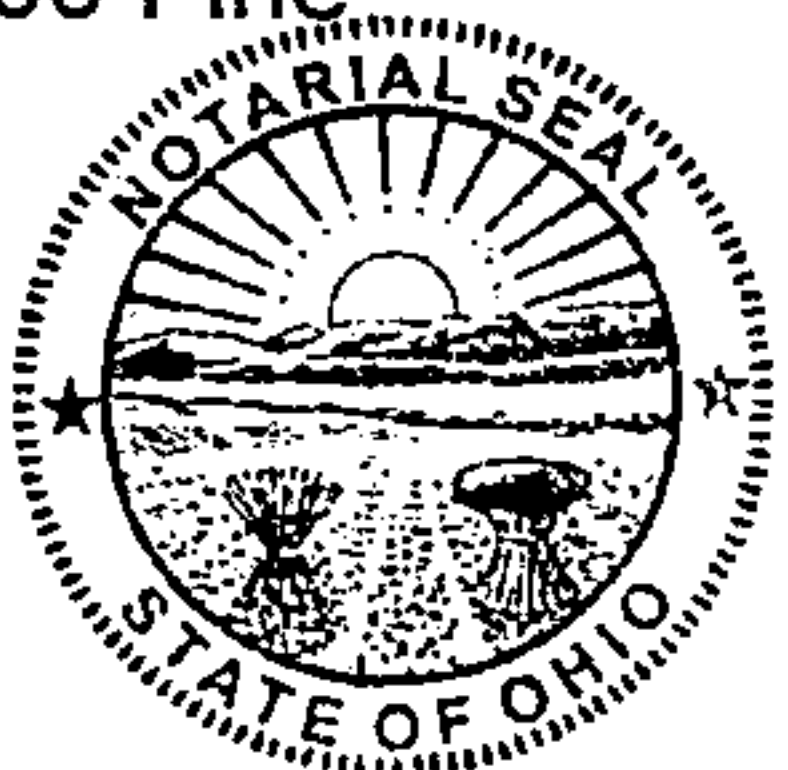

The Affiant, Officer M Lykins , being first sworn, says there is probable cause to believe the defendant, Phillip Lee Stevens , committed an offense based on the summary of facts below:

On 05-05-2025 at approximately 1452 hours, Officer M. Anderson and Officer Lykins (722L) were dispatched to St. in reference to assisting the Clark County Dog Warden's Office. Officers were advised that Phillip Stevens (Defendant) was listed at this residence and had several active warrants.

Officers located Mr. Stevens walking eastbound in an alley, approaching the address. Officer Lykins exited his drove his patrol vehicle west in the alley to make contact with Mr. Stevens due to the Dog Warden being in the front of the above listed address dealing with an aggressive dog. Officer Lykins attempted to make contact with Mr. Stevens, but he elected to run east towards S. Light St. Mr. Stevens then ran south on S. Light St. where he was apprehended by Bailiff R. Garman and a Good Samaritan. Mr. Stevens was placed in custody in the 200 block of S. Light St.

Mr. Stevens was searched incident to arrest. On Mr. Steven's person was a glass pipe with white residue in it. This was located in a cigarette carton. Additionally was a clear plastic bag with a hard rock substance that appeared white. Both of these items were collected and submitted into evidence under property receipt #: 38102. The unknown substance will be sent to BCI for chemical analysis.

Phillip Stevens was arrested on several warrants through the Clark County Municipal Court. He was also charged with possession drug paraphernalia. He was placed in the Clark County Jail and will appear in court on 05-06-2025.

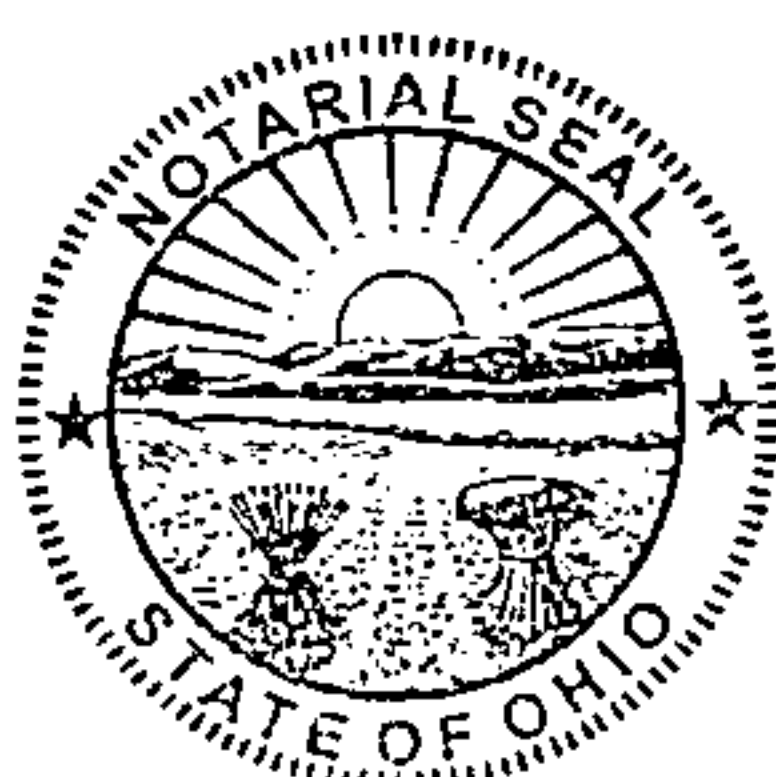


