The Affiant, Officer Huxley, being first sworn, says there is probable cause to believe the defendant, Daron Manuel Carr, committed an offense based on the summary of facts below:

On 05/07/2025 at approximately 2040 hours, Officer Hogan and I were dispatched to the lot across from headquarters reference an assault.

Upon arrival, Officers E. Taylor and Rofe were already on scene. We began speaking with \_\_\_\_\_ stated that she was at Family Dollar at 1207 N. Limestone St getting items for her and her friend, \_\_\_\_\_ stated that she was getting in her car to leave when Daron Carr showed up in a silver Dodge Avenger. Mr. Carr ran up to her vehicle yelling "Where's my bitch at?" This is referring to \_\_\_\_\_ friend \_\_\_\_\_ who is the mother of Mr. Carr's children. \_\_\_\_\_ was not with \_\_\_\_\_ at this time. \_\_\_\_\_ stated that as he was yelling this, Mr. Carr punched her twice through the slightly rolled down car window. Mr. Carr then was able to open the door and proceeded to punch \_\_\_\_\_ five to six more times. \_\_\_\_\_ stated that she had a knot on the back of her head where Mr. Carr had been hitting her.

Officer Rofe spoke to the witnesses, \_\_\_\_\_ and \_\_\_\_\_ stated that Mr. Carr came flying into the parking lot from Speedway, nearly hitting her and two other people. \_\_\_\_\_ stated she saw the suspect jump out of the car and start hitting \_\_\_\_\_ through the window. \_\_\_\_\_ then alerted her mother, \_\_\_\_\_ turned around and saw Mr. Carr hitting \_\_\_\_\_ with the car door open. \_\_\_\_\_ then yelled out for Mr. Carr to stop, causing him to flee in his vehicle. Once Mr. Carr fled, \_\_\_\_\_ and \_\_\_\_\_ stayed with \_\_\_\_\_ to make sure she was okay.

I did not observe any visible injuries on \_\_\_\_\_ face, but she was crying and very shaken up. \_\_\_\_\_ and the witnesses verified Mr. Carr's identity via OH BMV picture.
