The Affiant, Officer Amanda Rosales, being first sworn, says there is probable cause to believe the defendant, Jeremy Lee Creachbaum, committed an offense based on the summary of facts below:

On Thursday, May 8th, 2025 at approximately 0134 hours the Clark County Combined Dispatch Center dropped emergency tones for 1413 Lexington Ave where a male was assaulting a female and had a knife in his hand.

Officers spoke with the reporting party, _____ advised that she was attempting to help her father, Jeremy Creachbaum get to bed when he became agitated and stated he did not wish to go to bed yet. Mr. Creachbaum then went into the kitchen and grabbed a knife and stated that he was going to "pop the tires" on his girlfriend, _____ truck.
