The Affiant, Officer Hopewell, being first sworn, says there is probable cause to believe the defendant, Sterling Parker, committed an offense based on the summary of facts below:

On May 16, 2025, Officers Yankle and Hopewell were dispatched to _____ for a larceny call for service. Upon arrival, Officers spoke with the victim,

_____ advised she had an Amazon package taken from her front door. _____ stated her front door camera caught the incident on video. _____ showed Officers the video footage. Officers observed a black male, wearing a bright blue shirt, jeans, and white shoes walk out of _____ The male then walks over to _____ bends over, and takes what appears to be an Amazon package from _____ The male then walks down the steps out of sight of the camera.

_____ advised the male goes by "Country" and is her neighbor in Apt. G. She also stated he has done this before but was able to receive her package back. _____ knocked on Apt. G and tried to reason with the male stating "I won't call the cops if you just return the package". The male ignored her and closed the door. Later in another video, the male was observed in a different outfit, changing his cloths after _____ confronted him. The Amazon package was valued at approximately \$25.00.

Dispatch was able to find a male by the name of Sterling Parker with an alias of "Country". Officer Yankle had dispatch send a picture of Sterling to his phone. _____ was showed the photo and stated "that's him." Shayna advised Sterling likes to hang out front of the Apt. complex and also frequents the Sunoco on Sunset Ave. Officers checked the surrounding area for Sterling but was unable to locate him. _____ was advised to send the video to Officer Hopewell's email but did not know how to send it. Shayna was given a case number card for her records.
