### Complaint By Individual:

The Affiant, Detective J Allender, being first sworn, says there is probable cause to believe the defendant, Brandy Marie Simcox, committed an offense based on the summary of facts below:

On June 4, 2025, at approximately 0715 hours, the Springfield Police division executed a drug trafficking residential search warrant at Narcotics. Detectives cleared the residence and conducted a search of the residence shortly after.

Det. Burch, of the Springfield Police Division, located a Ruger LCP (serial # 372140581) in the northern most bedroom of the residence along with suspected narcotics.

The target of the investigation was Brandy SIMCOX and the room the firearm was located in contained some of her personal property. SIMCOX was the target of the drug trafficking investigation of that residence as well. SIMCOX has prior convictions for Possession of Drugs through the Champaign County Common Pleas Courts (2017CR269) and therefore cannot be in possession of a firearm.

Several drug trafficking items were seized along with the firearm (Springfield Property Receipt 22307) and were placed in the Springfield Police Evidence room in accordance to the SPD evidence collection policy and procedures. Further criminal charges pending lab results for the suspected narcotics.

SIMCOX was not present during the execution of the search warrant, therefore a warrant for Having Weapons Under Disability were requested.
