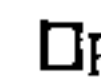

The Affiant, Officer T. Paden II, being first sworn, says there is probable cause to believe the defendant, Julna Julmiste, committed an offense based on the summary of facts below:

On 6/5/2025 I, Officer Paden and Officer Rofe along with Officers C. Williams, Phillips and SGT Taylor were dispatched to in reference to an Intoxicated Person.

Upon arrival, Officers spoke with EMS (Medic 8). Medics stated that Julna Julmiste had been outside unresponsive. Medics stated that there were two children inside of the home and possibly another child who was an infant. I, Officer Paden observed Julna performing snow angels in the gravel, Julna then attempted to stand up but, she immediately fell back down to the ground. Medics were able to get Julna inside of the Medic to get her ready for transport to SRMC.

Officers then entered inside of the home of Julna Julmiste. Officers located _____ (who will be identified as CV1 going forward) sitting at the rear entrance of the home. Officers then Observed _____ (who will be identified as CV2 going forward) walking around the home confused and crying. Officers asked CV2 were there any other children inside of the home, CV2 led Officers to the dining area. Officers located _____ (who will be identified as CV3 going forward) laying inside of the baby crib sleeping. CV2 was attempting to feed CV3, while Julna was outside intoxicated. Medics advised that they should take CV3 along with Julna to SRMC for medical evaluation. Medics then transported Julna and CV3 to SRMC.

Officers then attempted to make contact with relatives of Julna. Officers were not successful after several attempts. Officer Rofe then left the scene to meet Julna at SRMC. Officer Rofe stated that Julna was unresponsive and incoherent. Julna made multiple statements to Officer Rofe saying "just take my kids". Julna then stated to Officer Rofe and medical staff that due to the events that took place earlier that morning between her and her boyfriend Jeff Henry, she drank herself to death. Officer Rofe made several attempts to contact relatives, while at SRMC. Officer Rofe was unable to make contact with any relatives. CV3 is still being breast fed by Julna. Blood results for CV3 are still pending.

After several attempts to contact relatives, SGT Taylor then reached out to Child Services. Employees from Child Services, _____ arrived on scene. _____ gathered information from Officers. Officers made multiple attempts to find accurate names and DOB's for the children. Officers were able to gather approximate names and ages for the children. Child Services were able to gather multiple items, such as clothes, formula, and wipes for CV1, CV2 and CV3. _____ were given case numbers in reference this incident.

SGT Taylor then arrived at SRMC for further investigation. SGT Taylor was able to acquire the name of CV3 while investigating at SRMC.

Warrants were requested on Julna Julmiste for Endangerment.
