**The Affiant, Officer A.J. Turner, being first sworn, says there is probable cause to believe the defendant, Tyler Joseph Rhodes, committed an offense based on the summary of facts below:**

On July 9, 2025 Officers A.J. Turner and A. Johnson were dispatched to Springfield Regional Medical Center in reference to a domestic violence incident that had occurred at

Upon arrival, Officers met with the victim, \_\_\_\_\_ inside of \_\_\_\_\_, stated the father of her children, Tyler Rhodes, and her have recently been having issues with their relationship. She stated they have been together for about six years and have four children together. However, within the last few months have ended their relationship.

Around 9:33pm on 07/09/2025 \_\_\_\_\_ received a message from Mr. Rhodes via Facebook. \_\_\_\_\_ was able to provide these messages to officers that read, "I'm gonna make it real easy for you. I'm just gonna go grab this gun and I'm gonna blow your fucking head off watch." \_\_\_\_\_ replied to Mr. Rhodes saying she was going to press charges against him. Mr. Rhodes responded by telling \_\_\_\_\_ "...I promise you you're gonna have to press charges until I go to jail every day of your life you're gonna be scared."

\_\_\_\_\_ advised a short time later, Mr. Rhodes arrived at her home and broke into the front door. She stated she was in her bedroom at the time he entered the residence. She said Mr. Rhodes then grabbed one of her daughters toys, a Minnie Mouse "Ride-On" toy, and entered her bedroom where he struck her in the head with the toy. \_\_\_\_\_ advised he then \_\_\_\_\_ and began striking her about the arm and back. \_\_\_\_\_ had a visible laceration to \_\_\_\_\_ in the hairline that was bleeding. Additionally, Officers could observe significant red marks and scratches to her back. Ms. Church informed Officers she did not lose consciousness however when she was struck in the head, her vision became impaired. Describing it as "seeing black and blue" and that she "saw stars." Ms. Church stated immediately after the assault, Mr. Rhodes ran from the residence.

Officers returned to the home of Ms. Church and were able to observe damage to the front screen/storm door and there was glass on the front porch. Additionally, there was a broken window near the front door, however it is unclear if this was caused during the described incident.

Ms. Church's injuries and home were photographed by Officer A. Johnson. Additionally, a written statement was obtained from Ms. Church.

Warrants are being requested on Mr. Tyler Rhodes for Aggravated Burglary, Domestic Violence (A) & (C), Assault, and Aggravated Menacing.
